**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)**  
**(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 22nd October, 1956, and published under Public Instrument No. 1006 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Orta Keuy (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 399 of 1957, 888 of 1957, 219 of 1958 and 797 of 1958, the Order was extended for further periods of six months up to the 21st April, 1959.

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

And whereas by virtue of Public Instruments Nos. 1165 of 1956, 400 of 1957, 908 of 1957, 218 of 1958 and 795 of 1958, the Order was extended for further periods of six months up to the 23rd April, 1959.
