The following Bye-laws made by the Village Water Commission of Aghirda, in the District of Kyrenia, and approved by the Commissioner, are published in the Gazette.

BYE-LAWS MADE BY THE VILLAGE WATER COMMISSION OF AGHIRDA UNDER SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Aghirda village, hereby make the following bye-laws: -

1. These Bye-laws may be cited as the Village Domestic Water Supply (Aghirda) (Amendment) Bye-laws, 1959, and shall be read as one with the Village Domestic Water Supply (Aghirda) Bye-laws, 1956 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these Bye-laws may together be cited as the Village Domestic Water Supply (Aghirda) Bye-laws, 1956 and 1959.

2. Rule 10 of the principal Bye-laws is hereby amended by the deletion therefrom of the words "two pounds" and the substitution therefor of the words "ten pounds".

3. The proviso to Rule 10 of the principal Bye-laws is hereby amended by the deletion therefrom of the words "three shillings" and the substitution therefor of the words "four hundred mils".
