THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 5th November, 1956 and published under Public Instrument No. 1054 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorized the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Kato Lakatamia (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 499 of 1957, 965 of 1957, 303 of 1958 and 883 of 1958, the Order was extended for further periods of six months up to the 4th May, 1959 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Whereas by Order dated the 28th May, 1956 and published under Public Instrument No. 437 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorized the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Kato Polemidhia village (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 1165 of 1956, 498 of 1957, 961 of 1957, 304 of 1958 and 880 of 1958, the Order was extended for further periods of six months up to the 27th May, 1959 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :
