In exercise of the powers conferred upon him by section 3 of the Pensions Law, the Governor, with the advice of the Executive Council and with the sanction of the Secretary of State, hereby makes the regulations following:—

1. These Regulations may be cited as the Pensions (Amendment) Regulations, 1959 and shall be read as one with the Pensions Regulations as from time to time amended (hereinafter referred to as the "principal Regulations").

2. Regulation 19 of the principal Regulations is hereby amended by substituting a colon for the full stop at the end of sub-paragraph (b) of paragraph (2) and for the full stop at the end of sub-paragraph (c) of paragraph (3) thereof and by adding to each such sub-paragraph a proviso as follows:—

"Provided that for the purposes of this sub-paragraph an increase in the pensionable emoluments of an officer occasioned by the provisions of item (viii) of paragraph (a) of the definition of 'pensionable emoluments' as set out in sub-section (1) of section 2 of the Pensions Law shall be deemed to be an increase due to a revision of salaries."

3. The Appendix to the principal Regulations is hereby amended by inserting therein at the appropriate place so that the items shall be in alphabetical order the new item following:

"Secretary of State in respect of officers appointed under the Overseas Service Act, 1958, of the United Kingdom."

4. Regulation 2 of these Regulations shall be deemed to have come into force on the first day of January, 1957.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO 1959.
