THE POLICE LAW, 1958.

THE POLICE (GENERAL) REGULATIONS, 1958.

- 5 of 1958. In exercise of the powers conferred upon him by section 10 of the Police Law, 1958, the Chief Constable with the approval of the Governor hereby makes the following regulations :—
- Citation. 1. These Regulations may be cited as the Police (General) (Amendment)
P.I. : Regulations, 1959, and shall be read as one with the Police (General) Regu-
279/1958. lations, 1958 (hereinafter referred to as the "principal Regulations").
- Amendment of Regulation 6 of the principal Regulations. 2. Regulation 6 of the principal Regulations is hereby amended—
(i) by deleting the proviso to paragraph (3) thereof and by substituting therefor the proviso following :—
"Provided that the Chief Constable may at his discretion reduce or extend the period of probation or, if the constable has previous service in the Force, regard such service as the period of probation." ;
(ii) by deleting paragraph (4) thereof and substituting therefor the paragraphs following :—
" (4) A constable enlisted under Regulation 7 of these Regulations who is accepted for re-enlistment under this Regulation shall be deemed to have been enlisted under this Regulation as from the date of his enlistment under Regulation 7 and shall cease to be eligible for any gratuity payable under that Regulation.
(5) A constable enlisted under this Regulation may, at any time during the probationary period with the permission of the Chief Constable, elect to terminate his engagement and re-enlist under Regulation 7 of these Regulations and in such a case such constable shall be deemed to have been enlisted for a period of three years under that Regulation as from the date of his enlistment under this Regulation."
- Amendment of Regulation 7 of the principal Regulations. 3. Regulation 7 of the principal Regulations is hereby amended by deleting paragraph (4) thereof and by substituting therefor the paragraph following :—
" (4) A constable enlisted under this Regulation and whose service exceeds one year shall upon the termination of his engagement be eligible for a gratuity of twenty pounds in respect of the first year of his service and of five pounds in respect of such consecutive period of three months service thereafter."
