ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in me by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, Bertram John Weston, Commissioner of Nicosia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the Community, have taken possession with immediate effect of the premises specified in the Schedule hereto until further notice.

2. The use of the said premises for the requirements of Her Majesty's Forces is hereby authorised.

3. The authority using the premises in pursuance of this Order is entitled to do thereon or in relation thereto such acts as may be necessary for the purpose of their occupation.

4. The exercise of any right of way over the premises and of any other right relating thereto which is enjoyed by any person whether by virtue of an interest in the premises or otherwise is hereby prohibited during the period this order shall remain in force.
