THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 18th December, 1956, and published as Public Instrument No. 1267 of 1956 as amended by Public Instrument No. 1045 of 1957, hereinafter referred to as "the Order", the Governor authorized the use of the land and property specified in the Order subject to the restrictions and conditions therein contained for military purposes during the period of six months commencing the 18th December, 1956 :

And whereas by virtue of Public Instruments Nos. 612 and 1046 of 1957, 361 of 1958 and 246 of 1959, the Order was extended for further periods of six months up to the 17th June, 1959 :

And whereas the Governor is satisfied that the land and property should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers conferred upon him by Defence Regulation 64 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorized the use of the land and property specified in the Orders and subject to the restrictions and conditions therein contained for a further period of six months commencing the 18th June, 1959.

(CYPRUS) ORDER, 1946.

Whereas by Order dated the 6th January, 1956, and published as Public Instrument No. 14 of 1956 as amended by Public Instrument No. 333 of 1956, hereinafter referred to as "the Order", the Governor authorized the use of the land and property specified in the Order subject to the restrictions and conditions therein contained for military purposes during the period of six months commencing the 6th January, 1956 :

And whereas by virtue of Public Instruments Nos. 642 of 1956, 1284 of 1956, 710 of 1957, 1111 of 1957, 1020 of 1958 and 49 of 1959, the Order was extended for further periods of six months up to the 5th July, 1959 :

And whereas the Governor is satisfied that the land and property should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers conferred upon him by Defence Regulation 64 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorized the use of the land and property specified in the Orders and subject to the restrictions and conditions therein contained for a further period of six months commencing the 6th July, 1959.

**THE VILLAGE AUTHORITIES LAW.**

**CAP. 256 AND LAWS 17 OF 1951, 60 OF 1955 AND 30 OF 1957.**

**SPECIAL AUTHORIZATION UNDER SECTION 14(1).**
