# THE LOAN (DEVELOPMENT) (STOCK) REGULATIONS, 1958.

ORDER MADE UNDER REGULATION 3 (1).

In exercise of the powers conferred upon him by paragraph (1) of Regulation 3 of the Loan (Development) (Stock) Regulations, 1958, the Governor makes the Order following :---

1. This Order may be cited as the Loan (Development) (Stock) (Amendment of Schedule) Order, 1959.

2. The Schedule to the Loan (Development) (Stock) Regulations, 1958, is hereby amended to provide for further issue of stock by the addition of the item following:

THE CONTAGIOUS DISEASES (ANIMALS) LAW.

## (CAP. 65)

### ORDER MADE UNDER SECTION 4.

In exercise of the powers vested in him by section 4 of the Contagious Diseases (Animals) Law (Cap. 65), His Excellency the Governor is pleased to order and it is hereby ordered as follows :---

1. This Order may be cited as the Bee Diseases (Prevention) Order, 1959.

2. In this Order, unless the context otherwise requires-

"Bee " means the honey producing insect (Apis mellifera, L);

"Bee diseases" means the American Foul Brood (Bacillus larvae, White) and the European Foul Brood (Bacillus pluton, White);

"Bee-hive" means the container of a colony of bees;

"Bee-keeper" means the owner, or other person in charge of bee-

hives ; "Director" means the Director of Agriculture and any other person by him in writing, to act for him for the purposes of this Order,

3. Within any district, area or place declared by the Director to be infected with bee diseases the following provisions shall have effect :---

- (a) Every bee-keeper shall inform the Director in writing of the number and kind of bee-hives in his possession and the exact location where they are kept;
- (b) Every bee-keeper shall, on request, show the Director the place where the bee-hives are situated and allow him to examine them;
- (c) Any bee-hive found to be infected with the disease Foul Brood may on the instructions, and in the presence of the Director be destroyed together with its contents;
- (d) Any bee-hives within the apiary in which infection is found shall be subjected to any treatment, at the owner's expense, which the Director may require.

4. The Director may, by notice in the *Gazette*, prohibit within any infected district, area or place :---

- (a) the movement, except under written permit, of bees, bee-hives, honey, wax or other bee product and of any appliance used in the extraction or preparation of honey, wax or other bee product.
- (b) the keeping of bees in specified types of bee-hives.

5. No compensation shall be payable in respect of any bee-hive or its contents destroyed or treated under the provisions of this Order.

6. Any contravention of any of the provisions of this Order shall render the offender liable to the penalties imposed by section 9(1) of the Contagious Diseases (Animals) Law.

7. The Director is hereby authorised and appointed to see that the provisions of this Order are carried into effect.
