**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CONTINUATION) LAWS, 1958 AND 1959.**

**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 79B (1) (b).

Whereas a trade dispute exists between the employees of the Electricity Authority of Cyprus and the said Authority ;

And whereas all works and undertakings concerned in the production or supply of electrical energy are essential works for the purposes of the Essential Works Order, 1943 ;

And whereas a strike has been declared by the said employees :

Now, therefore, in exercise of the powers vested in him by sub-paragraph (b) of paragraph (1) of Defence Regulation 79B of the Defence Regulations (as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946), which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has been pleased to make the following Order :—

1. This Order may be cited as the Prohibition of Strike (Electrical Energy) Order, 1959.

2. Pending the determination of the trade dispute between the employees of the Electricity Authority of Cyprus and the said Authority by a Tribunal to be established for that purpose, all employees of the Electricity Authority of Cyprus and all persons employed in works and undertakings concerned in the production or supply of electrical energy are hereby prohibited from striking and the employers of such employees and persons so employed are likewise prohibited from locking out such employees or persons so employed.

3. This Order shall be in force for a period of one month from the date hereof and shall then expire.
