(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 79B (1) (a).

In exercise of the powers vested in him by sub-paragraph (a) of paragraph (1) of Defence Regulation 79B of the Defence Regulations (as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946), which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has been pleased to make the following Order :—

1. This Order may be cited as the Trade Dispute (Electricity Authority of Cyprus) (Tribunal) Order, 1959.
 2. In this Order, unless the context otherwise requires—
 - “ trade dispute ” means the existing trade dispute between the Electricity Authority of Cyprus and its servants or employees connected with the employment of certain persons ;
 - “ tribunal ” means the tribunal established under this Order.
 - 3.—(1) A tribunal is hereby established for the settlement of the trade dispute consisting of :—
 - (a) Mr. T. E. Fallows, Trade Union Adviser, *Chairman*.
 - (b) Mr. C. A. Ashiotis, M.B.E., Assistant Commissioner of Labour.
 - (c) Mr. M. Salahiddin, Administrative Officer, Ministry of Labour and Social Insurance.
- } *Members.*
- (2) The terms of reference of the tribunal shall be as follows :—

“ To examine the existing dispute regarding the appointment of Station Watchmen by the Electricity Authority, particularly the cases of all the men who were formerly employed as Watchmen by the Authority and who were recently either dismissed or assigned to other work, to advise whether any of these men possess the necessary qualifications for appointment as Station Watchmen, and to make recommendations.”
 - 4.—(1) The tribunal shall inquire into the trade dispute and make its award without delay :

Provided that in case of disagreement the majority's award shall be the award of the tribunal.
 - (2) The award shall be submitted to the Governor who shall as soon as possible cause the same to be published in the *Gazette* and thereupon such award shall be binding on all parties.
 5. The tribunal shall regulate its own procedure and shall not be bound by the rules of evidence in civil or criminal cases.
