REGULATIONS MADE UNDER SECTION 3.

In exercise of the powers conferred upon him by section 3 of the Pensions Law, the Governor, with the advice of the Executive Council and with the sanction of the Secretary of State, hereby makes the regulations following : —

1. These Regulations may be cited as the Pensions (Amendment) (No. 2) Regulations, 1959, and shall be read as one with the Pensions Regulations as from time to time amended (hereinafter referred to as the "principal Regulations").

2. The principal Regulations are hereby amended by inserting immediately after Regulation 23A the Regulation following : —

"Service in the English School by persons not teachers.

23B. Notwithstanding anything in these Regulations contained, when a person who, having served in a full time capacity as the bursar or as a clerk or as the matron in the English School employed by the Board of Management of the said school, is appointed without any break to the service of the Government, any period of service as such bursar or clerk or matron as the case may be shall be taken into account for the purposes of these Regulations."

Addition of new regulation 23B.

3. The Appendix to the principal Regulations is hereby amended by inserting therein at the appropriate place so that the items shall be in alphabetical order the new item following : —

"West Indies (Federation)".

THE WATER SUPPLY (MUNICIPAL AND OTHER AREAS)
LAWS, 1951 AND 1952.

APPOINTMENT OF MEMBERS AND DESIGNATION OF CHAIRMAN
UNDER SECTION 4.

It is hereby notified that in exercise of the powers vested in him by section 4 of the Water Supply (Municipal and Other Areas) Laws, 1951 and 1952, His Excellency the Governor has been pleased to appoint the following persons as members of the Water Board of Limassol with effect from the 4th September, 1959 : —

The Commissioner of Limassol.

The Director of Water Development or, in his absence or inability, the Senior Engineer of the Department of Water Development responsible for town water supplies.

The Accountant-General or, in his absence or inability, the Assistant Accountant-General of the Treasury.

2. His Excellency hereby designates the Commissioner of Limassol to be the Chairman of the said Water Board.
