THE DEFENCE (IMPORTATION OF GOODS) REGULATIONS,  
1956.

NOTICE.

*Importation of Shotguns and Air Rifles of less than 177 calibre.*

Any person who is in possession of a valid licence to import firearms issued on or after 1st September, 1959, by the Chief Constable under the provisions of section 4 of the Firearms Law (Cap. 86 as amended by Law 30 of 1955) is hereby authorized for the purposes of the Defence (Importation of Goods) Regulations, 1956, to import the firearm specified in such licence. Provided that such firearm shall have been manufactured in the United Kingdom or any dependent country of the United Kingdom or any of the countries listed in the first paragraph of Open General Licence No. 19,999.
