THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 3rd October, 1957, and published as Public Instrument No. 915 of 1957, hereinafter referred to as "the Order", the Governor authorized the use of the land and property specified in the Order subject to the restrictions and conditions therein contained for military purposes during the period of six months commencing the 3rd October, 1957:

And whereas by virtue of Public Instruments Nos. 229 of 1958, 1012 of 1958, and 232 of 1959, the Order was extended for further periods of six months up to the 2nd October, 1959:

And whereas the Governor is satisfied that the land and property should continue to be used for military purposes for a further period of four months:

Now, therefore, in exercise of the powers conferred upon him by Defence Regulation 64 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorized the use of the land and property specified in the Orders and subject to the restrictions and conditions therein contained for a further period of four months commencing the 3rd October, 1959.

No. 490. THE BOMBARDMENT RANGE AREAS LAW.

CAP. 222 AND LAW 23 OF 1951.

NOTICE UNDER SECTION 2.

In exercise of the powers vested in him by section 2 of the Bombardment Range Areas Law, as contained in the Bombardment Range Areas (Amendment) Law, 1951, His Excellency the Governor is pleased to declare the area set out in the Schedule hereto to be a Bombardment Range Area for the use of Her Majesty's Forces for a period of three calendar months from the 29th day of October, 1959, and is further pleased to declare that the said area shall be a practice area for the use of all kinds of small arms and the ammunition therefor.

SCHEDULE.

The Ayia Irini Bombardment Range Area.

1. *Sea Danger Area* : That area of Cyprus territorial waters contained by an arc drawn through the following positions on Admiralty Chart No. 776 (Cyprus—North Coast, Stazousa Point to Cape Limniti) of the 24th September, 1954 :—

35°	19.7' N	32°	56.2' E
35°	19.2' N	32°	55.2' E
35°	18.3' N	32°	54.7' E

and by a straight line through the following positions on the said Chart :

35°	18.3' N	32°	54.7' E
35°	17.9' N	32°	56.3' E

2. *Land Danger Area* : The boundary commences at a point on the coast about 100 yards due north of the mouth of the River Papa Vassili ; thence in a south-easterly direction for about 3,200 yards ; thence in a south south-westerly direction for about 1,400 yards ; thence in a west north-westerly direction to a point on the coast about 400 yards due south of the mouth of the River Paleokastron. The said boundary includes part of the localities " Ammoudhiaes ", " Navas " and " Paleokastron " of the village of Kormakiti and " Paleokastron " of the village of Ayia Irini in the District of Kyrenia.

All which said boundary is marked more particularly on the ground by danger notices situated at prominent points warning all persons in English, Greek and Turkish to keep away from the Danger Area when red flags (or red lights by night) are displayed on the beach at the points marking the northern and southern limits of the Danger Area and at the control Tower situated at the south-eastern landward limit of the Danger Area ; and on the map 1 : 50,000 Cyprus, Sheet 3, Ayia Irini, by points, map reference 653 866, 667 841, 659 831, and 655 832.

No. 491. THE LAND ACQUISITION LAW.
CAP. 233 AND LAW 26 OF 1957.

NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to His Excellency the Governor that it is desirable in the public interest to construct roads in the vicinity of Dhekelia, Akhna and Episkopi:

Now, therefore, in exercise of the powers vested in him by sections 2, 3 and 5 of the Land Acquisition Law, His Excellency the Governor does hereby declare the construction of the aforesaid roads to be an undertaking of public utility, and does hereby authorise the carrying out of the said undertaking, and does hereby entrust the supervision and effectuation of the said undertaking to the Director of Public Works.
