And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1958), His Excellency the Governor has authorized the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 9th January, 1959.
