ORDER IN COUNCIL No. 3108

MADE UNDER SECTION 10.

*Authority to the Village Health Commission of Menoyia
(Larnaca District) to contract a loan.*

In exercise of the powers vested in him by section 10 of the Public Health (Villages) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

1. The Village Health Commission of Menoyia (Larnaca District) (hereinafter referred to as "the Village Health Commission") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of three hundred and fifty pounds (£350) at a rate of interest not exceeding five per centum (5%) per annum, subject to the following terms and conditions, that is to say:—

- (a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in ten equal annual instalments (comprising sinking fund and interest);
- (b) the Village Health Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual instalment payable in the year to which such estimates relate;
- (c) the sum borrowed shall be utilized by the Village Health Commission for the asphaltting of the village streets.

2. For the purpose of securing the repayment of the sum due under the loan the Village Health Commission is hereby authorised, subject to any prior mortgage thereon, to mortgage to the Lender all the fees, charges and rates now payable or hereafter to become payable to the Village Health Commission under the provisions of the Public Health (Villages) Law.

*Authority to the Village Health Commission of Pervolia
(Larnaca District) to contract a loan.*

In exercise of the powers vested in him by section 10 of the Public Health (Villages) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

1. The Village Health Commission of Pervolia (Larnaca District) (hereinafter referred to as "the Village Health Commission") shall be at liberty to borrow from the Public Loans Fund (hereinafter referred to as "the Lender") the sum of three hundred and forty pounds (£340) at a rate of interest not exceeding five per centum (5%) per annum, subject to the following terms and conditions, that is to say :—

- (a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in ten equal annual instalments (comprising sinking fund and interest);
- (b) the Village Health Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates

as a charge on its revenues the annual instalment payable in the year to which such estimates relate ;

- (c) the sum borrowed shall be utilized by the Village Health Commission for the asphaltting of the village streets.

2. For the purpose of securing the repayment of the sum due under the loan the Village Health Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the fees, charges and rates now payable or hereafter to become payable to the Village Health Commission under the provisions of the Public Health (Villages) Law.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATIONS 64 AND 102.

In exercise of the powers conferred upon him by Defence Regulations 64 and 102, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor hereby varies the Order made by him under Defence Regulation 64 on the 13th day of August, 1956, and published as Public Instrument No. 773 of 1956 (as extended by Public Instruments Nos. 74 of 1957, 748 of 1957, 56 of 1958, 994 of 1958, 99 of 1959 and 399 of 1959 and as amended by Public Instruments Nos. 69 of 1958 and 328 of 1958) (hereinafter referred to as "the principal Order") as follows (without prejudice to anything done or left undone thereunder) :—

- (a) by the deletion from the Second Schedule to the principal Order of the Plot Nos. and words as set out in the Schedule hereto ;
- (b) by the addition of the word "(Part)" immediately after the figure "1512" in line eleven of the Schedule to the principal Order ;
- (c) by the deletion of the words "Plan signed by the Assistant Director of Lands, Cyprus, dated the 18th April, 1958" from lines fifteen and sixteen of the Second Schedule to the principal Order and the substitution therefor of the words "Plan signed by the Assistant Director of Lands, Cyprus, dated the 20th October, 1959".

And that part of the principal Order which relates to the Plot Nos. and words set out in the Schedule hereto is hereby revoked.
