ORDER MADE BY THE GOVERNOR UNDER DEFENCE  
REGULATIONS 64 AND 102.

In exercise of the powers conferred upon him by Defence Regulations 64 and 102, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor hereby varies the Order made by him under Defence Regulation 64 on the 9th day of August, 1956, and published as Public Instrument No. 767 of 1956 (as extended by Public Instruments Nos. 74 of 1957, 748 of 1957, 66 of 1958, 992 of 1958, 100 of 1959 and 391 of 1959, and as amended by Public Instrument No. 88 of 1958) (hereinafter referred to as "the principal Order") by the deletion of Plot No. "530" from the Second Schedule to the principal Order, without prejudice to anything done or left undone thereunder.

And that part of the principal Order which relates to Plot No. 530 is hereby revoked.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE

In exercise of the powers conferred upon him by Defence Regulations 64 and 102, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor hereby varies the Order made by him under Defence Regulation 64 on the 17th January, 1959, and published as Public Instrument No. 40 of 1959 (as varied by Public Instrument No. 106 of 1959 and as extended by Public Instrument No. 347 of 1959) (hereinafter referred to as "the principal Order") by the deletion from the Second Schedule to the principal Order of the words "plan signed by the Assistant Director of Lands, Cyprus, dated 30th January, 1958", and the substitution therefor of the words "plan signed by the Assistant Director of Lands, Cyprus, dated 20th October, 1959" (without prejudice to anything done or left undone thereunder).
