(" KRYOS-YEROKOLYMBOS ") RULES, 1931.

DISSOLUTION OF THE IRRIGATION DIVISION OF LEFKONIKO  
(" KRYOS-YEROKOLYMBOS ").

Whereas an application was made to the Commissioner of Famagusta signed by not less than three-fourths of the proprietors requesting that the Irrigation Division of Lefkoniko (" Kryos-Yerokolymbos ") (hereinafter referred to as the " Irrigation Division ") be dissolved ;

And whereas at a meeting of the proprietors of the Irrigation Division held under Rules 17 (a) and 17 (b) of the Irrigation Division of Lefkoniko (" Kryos-Yerokolymbos ") Rules, 1931 (hereinafter referred to as the " Rules ") at the village of Lefkoniko on the 11th October, 1959, it was unanimously decided by the voters present thereat that the said Irrigation Division should be dissolved :

Now, therefore, it is hereby notified that the Irrigation Division has been dissolved accordingly as from the 11th October, 1959, subject to the reservations and exceptions contained in the Rules.
