

No. 575. THE PUBLIC HEALTH (VILLAGES) LAW.
CAP. 142.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF TRAKHONAS
UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Trakhonas hereby make the following Rules:—

1. These Rules may be cited as the Village Health (Trakhonas) (Amendment No. 2) Rules, 1959, and shall be read as one with the Village Health (Trakhonas) Rules, 1940 and 1959 (hereinafter referred to as "the principal Rules"), and the principal Rules and these Rules may together be cited as the Village Health (Trakhonas) Rules, 1940 to 1959.

2. Rule 86 of the principal Rules is hereby amended by the deletion therefrom of the figure "5s." and the substitution therefor of the figure and word "£10.000 mils."

The above rules have been approved by the Commissioner of Nicosia.

No. 576. THE PUBLIC HEALTH (VILLAGES) LAW.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF PANO POLEMIDHIA
IN THE LIMASSOL DISTRICT UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Pano Polemidhia hereby make the following rules:—

1. These rules may be cited as the Village Health (Pano Polemidhia) Rules, 1959, and shall come into operation on their publication in the *Gazette*.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Nikos) Rules, 1952 (hereinafter referred to as the "Model Rules"), published in Supplement No. 3 to the *Gazette* of the 19th November, 1952, shall—

(a) be deemed to be rules made by the Village Health Commission of Pano Polemidhia and to be incorporated herein, and

(b) apply to the village of Pano Polemidhia:

Provided that for the word "Nikos" and for the word "Nicosia" wherever they occur in the Model Rules, the word "Pano Polemidhia" and the word "Limassol" shall be substituted respectively.

(2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Nikos) Rules, 1952.

(3) Those rules of the Village Health (Nikos) Rules, 1952, mentioned in Part II of the Schedule hereto, shall not apply to the village of Pano Polemidhia.

SCHEDULE.

PART I.

RULES TO BE SUBSTITUTED.

Rule 19. The following fees shall be paid by the owner of or the person slaughtering any animal in the slaughter-house, that is to say:—

(a) For every bullock, camel, cow or ox	mils.
(b) For every goat, kid, lamb or sheep	200.

Rule 31. The following fees shall be paid by every person exposing for sale any perishable goods in the market of perishable goods, that is to say:—

(a) For every load of goods of 30 okes or under	mils.
(b) For every load of goods over 30 okes	015

(c) For every motor-lorry or cart of goods	050

Rule 45. The following fees shall be paid by every person exposing for sale fresh meat in the meat market, that is to say:—

(a) For every carcass of sheep or goat or part thereof	mils.
(b) For every carcass of a young lamb or kid or part thereof	025

(c) For every carcass of ox, camel, cow or bullock or part thereof	050

Rule 1.

The above rules, in so far as they relate to matters referred to in paragraphs (b), (c) and (d) of section 9 (1) of the Public Health (Villages) Law, have been approved by the Commissioner and, in so far as they relate to matters referred to in paragraphs (a) and (e) of the said section of the said Law, have been approved by the Commissioner and the Director of Medical Services.
