ORDER MADE BY THE GOVERNOR UNDER SECTION 42 (1).

1. This Order may be cited as the Election of President (Closing of Licensed Premises) Order, 1959.

REGULATIONS MADE UNDER SECTIONS 19 (1) AND 43.

In exercise of the powers vested in him by sections 19 (1) and 43 of the 37 of 1959 Elections (President and Vice-President of the Republic) Laws, 1959, His 41 of 1959 Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following Regulations :--

1. These Regulations may be cited as the Elections (President and Vice-President of the Republic) (Greek Polling Districts) (Amendment) Regulations, 1959, and shall be read as one with the Elections (President and Vice-President of the Republic) (Greek Polling Districts) Regulations, P.I.: 1959 (hereinafter referred to as "the principal Regulations").

2. The Schedule to the principal Regulations is hereby amended as follows :---

- (a) By the deletion of the brackets and words "(Kato Yialia)" appearing in the first column thereto under the heading "The Greek Constituency of Paphos";
- (b) By the insertion in the second column thereto under the same heading and immediately after the words "Nea Dhimmata" of the following new item "(c) Kato Yialia";
- (c) By the insertion in the second column thereto under the same heading and immediately after the word "Magounda" of the following new item "(e) Ayios Isidhoros".
