### THE WIRELESS TELEGRAPHY LAWS, 1952 AND 1955.

ORDER MADE UNDER SECTION 3 (1).

In exercise of the powers vested in him by the proviso to sub-section (1) of section 3 of the Wireless Telegraphy Laws, 1952 and 1955, the Governor has been pleased to order as follows:—

1. This Order may be cited as the Wireless Telegraphy (Kingdom of Greece) (Exemption) Order, 1959.

2. The establishment, installation, use and maintenance by the Government of the Kingdom of Greece of the wireless telegraphy apparatus specified in the Schedule hereto is hereby exempted from the provisions of sub-section (1) of section 3 of the Wireless Telegraphy Laws, 1952 and 1955.

THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW.

CAP. 311 AND LAWS 28 OF 1951, 12 OF 1952 AND 13 OF 1957.

The following bye-laws made by the Water Commission of Lysi village in the District of Famagusta, and approved by the Commissioner, are published in the *Gazette*.

Bye-laws made by the Village Water Commission of Lysi Village under Section 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Lysi village hereby make the following Bye-laws:—

I. These Bye-laws may be cited as the Village Domestic Water Supply (Lysi) (Amendment) Bye-laws, 1959, and shall be read as one with the Village Domestic Water Supply (Lysi) Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Village Domestic Water Supply (Lysi) Bye-laws, 1951 to 1959.

2. Bye-law 10 of the principal Bye-laws is hereby amended as follows: ----

- (a) by the deletion of the words " two pounds " appearing in the second line and the substitution therefor of the words " five pounds ";
- (b) by the deletion in the proviso thereof of the words "3s. per thousand gallons" and the substitution therefor of the words "350 mils per thousand gallons".

The above bye-laws have been approved by the Commissioner of the District of Famagusta. (M.I. 948/59.)
