No. 615. THE REGISTRATION OF ELECTORS LAW, 1959.

APPOINTMENT OF ASSISTANT REGISTRARS OF ELECTORS UNDER SECTION 7 (3).

In exercise of the powers vested in him by sub-section (3) of section 7 of the Registration of Electors Law, 1959, His Excellency the Governor has, as from the 12th November, 1959, been pleased to appoint for the purposes of the said Law—

- (a) the persons specified in the first column of Part I of the Schedule hereto to be Greek Assistant Registrars of Electors for the Greek Constituencies specified in the second column of the said Schedule ;
and

(b) the persons specified in the first column of Part II of the Schedule hereto to be Turkish Assistant Registrars of Electors for the Turkish Constituencies specified in the second column of the said Schedule :-

No. 616. THE REGISTRATION OF ELECTORS LAW, 1959.

ORDER MADE UNDER SECTION 2 (3).

In exercise of the powers vested in him by sub-section (3) of section 2 of the Registration of Electors Law, 1959, as amended by section 4 of the Registration of Electors (Additional Registrations) Law, 1959, His Excellency the Governor has been pleased to order as follows :—

1. This Order may be cited as the Registration of Electors (Individual Options : Additional Registrations) Order, 1959, and shall be read and construed as one with the Registration of Electors (Individual Options) Order, 1959. P.I.: 547/1959.

2. The persons whose names and particulars are set out in the Schedule hereto, having declared in writing to the Governor, under the provisions of sub-section (3) of section 2 of the Registration of Electors Law, 1959, that they fulfil each of the requirements (i) to (iii) specified in the said sub-section (3) of section 2, and the other requirements of sub-section (2) of section 4 of the said Law, and that they desire to be registered in a Greek Register of Electors, the Governor, being satisfied of all matters contained in such declarations, has been pleased to declare, and it is hereby declared, that such persons shall be registered in a Greek Register of Electors.
