

THE MUNICIPAL CORPORATIONS LAW.

CAP. 252 AND LAWS II OF 1950, 31 OF 1951, 20 OF 1953, 29 OF 1954, 57 OF 1954 AND 14 OF 1955.

NOTIFICATION UNDER SECTION 129.

Whereas the property described in the Schedule hereto is required by the Municipal Council and townsmen of Limassol (hereinafter referred to as "the municipal corporation") for the purpose of erecting a Wholesale Market and providing a Parking Place within the Municipal Limits of Limassol;

And whereas the formalities prescribed by sections 127 and 128 of the Municipal Corporations Law have been complied with;

And whereas the Governor has approved the plan submitted in that behalf, and considers it expedient, having regard to all the circumstances, that the municipal corporation should be permitted to acquire the said property for the above public purpose:

Now, therefore, in exercise of the powers vested in him by section 129 of the Municipal Corporations Law, His Excellency the Governor hereby sanctions the acquisition of the property described in the Schedule hereto by the municipal corporation.
