## THE CYPRUS LAWS (REVISED EDITION) LAW, 1959.

## PROCLAMATION UNDER SECTION 9.

HUGH FOOT,  
Governor.

Whereas by the Cyprus Laws (Revised Edition) Law, 1959 (hereinafter referred to as "the Law") provision was made for the preparation and publication of a new and revised edition of the Laws of Cyprus as in force on the 1st April, 1959 :

And whereas Mr. Criton George Tornaritis, Q.C., was appointed Commissioner for the purpose of preparing the new and revised edition of the Laws of Cyprus as aforesaid :

And whereas by the proviso to section 9 of the Law it is provided that the Governor may, before the completion and publication of the revised edition, approve, by proclamation published in the *Gazette*, any Chapter, compiled and printed under the provisions of the Law, specified in the proclamation and order that such Chapter shall come into force from such date as may be specified in the proclamation :

And whereas the Chapters of the aforesaid revised edition relating to the Criminal Code and the Criminal Procedure Law have been compiled and printed under the provisions of the Law before the completion and publication of the aforesaid revised edition :

And whereas it appears to me desirable that the aforesaid Chapters should be approved and should come into force before the completion and publication of the aforesaid revised edition :

Now, therefore, in exercise of the powers vested in me by the aforesaid proviso to section 9 of the Law, I, the Governor, do, by this proclamation, approve Chapter 154 (The Criminal Code) and Chapter 155 (The Criminal Procedure Law) of the aforesaid revised edition and order that the said two Chapters shall come into force as from the 15th January, 1960.
