THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 6) 1958.

## ORDER MADE UNDER REGULATION 44.

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorize its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1958, which I have been authorized to exercise under Notification No. 780 published in Supplement No. 3 to the *Gazette* of the 16th October, 1958, I, the Commissioner of Limassol, hereby take possession of land and, in connection with the taking possession and making use of the land, I hereby direct and order as follows :—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorized.
- (2) The persons using the land in pursuance of this order are hereby authorized to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise is hereby prohibited.

## SCHEDULE.

All those privately owned premises comprising the ground floor flat of the dwelling house and the adjoining land under Plot 4/1, the land only under Plot 4/2, of Plan 58.3.II, IV, Sheet LIV, Ayia Trias Quarter, Limassol Town, more particularly defined as the area bounded in red in the plan signed by the Commissioner of Limassol and dated the 17th day of May, 1956.

## VARIATION OF ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in me by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1958, I, the Commissioner of Limassol, hereby vary the Order made under Regulation 44 and published in Supplement No. 3 to the *Gazette* of the 10th October, 1957, under Notification No. 928, so as to exclude from the said Order the land described in the Schedule hereto.

All that privately owned land in Limassol town, being parts of Plots Nos. 78/3, 78/4, 78/12 and 78/13 on the Government Survey Sheet/Plan LIV/58.2.1, and more particularly defined as the area coloured blue on the Plan signed by the Commissioner of Limassol and dated 18th September, 1957, a copy of which is available for inspection at the Office of the Commissioner of Limassol.
