NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to His Excellency the Governor that it is desirable for military purposes to provide for the passage of water to the military cantonment, described in the Notification made by His Excellency the Governor on the 22nd January, 1953, and published as Public Instrument No. 30 of 1953, which is to pass through the villages of Kissousa, Mallia, Pakhna, Dhora, Anoyira, Evdhimou, Paramali and Sotira in the District of Limassol (hereinafter referred to as "the undertaking") the cost whereof is to be borne by Her Majesty's War Department :

Now, therefore, in exercise of the powers vested in him by sections 2, 3 and 5 of the Land Acquisition Law, His Excellency the Governor has been pleased to declare this undertaking to be an undertaking of public utility, and has been pleased to authorize the carrying of the said undertaking under the provisions of the said Law, and has further been pleased to entrust the supervision and effectuation of the said undertaking to the Assistant Director of Lands, Cyprus, British Forces Post Office 53, for the time being.

No. 14. THE LAND ACQUISITION LAW.

NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 13 of 1960, notice is hereby given that the following land is required and the following easements, privileges and liberties are required to be created and acquired for the undertaking of the public utility mentioned therein :—

- (i) All those areas of privately-owned land with everything standing thereon, situated in the village of Anoyira in the District of Limassol, comprising 2 donums and 1 evlek or thereabouts including plot No. 137/2, locality "Laonistra", of the Government Survey Plan No. LII.22, and part of plot No. 159, locality "Apikreni", of the Government Survey Plan No. LII.38. 3. Her Majesty's Secretary of State for War is willing to treat for the acquisition of the said land, easements, privileges and liberties.

4. The plans mentioned above are available for inspection in my office.

5. The period mentioned in paragraph 2 hereof has been abridged to ten days with the approval of His Excellency the Governor.
