BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION  
OF LARNACA.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1955, and otherwise, the Council of the Municipal Corporation of Larnaca hereby make the following bye-laws :---

1. These bye-laws may be cited as the Municipal Corporation (Larnaca) Pensions and Gratuities (Amendment) Bye-laws, 1960, and shall be read as one with the Municipal Corporation (Larnaca) Pensions and Gratuities Bye-laws, 1955 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Larnaca) Pensions and Gratuities Bye-laws, 1949 to 1960.

2. Bye-law 180 of the principal Bye-laws is hereby amended by the substitution for the definition of "salary" therein contained of the following definition, i.e. :—

" 'salary' means the annual salary of an officer as approved by the Commissioner under the provisions of the law, or where no such approval is required, the annual salary of an officer as may be appointed by the Council plus, in each case, any cost-of-living allowance paid to an officer but so that in no case such allowance to exceed twelve and a half per centum of the salary of any such officer."

3. This Bye-law shall be deemed to have come into force on the 1st day of January, 1960.

The above Bye-laws have been approved by His Excellency the Governor.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION  
OF MORPHOU.

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Morphou, hereby make the following bye-laws :—

1. These bye-laws may be cited as the Morphou Municipal (Amendment) Bye-laws, 1960, and shall be read as one with the Morphou Municipal Bye-laws, 1941 to 1959 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Morphou Municipal Bye-laws, 1941 to 1960.

2. Bye-law 2 of the principal Bye-laws is hereby amended by substituting for the definition of "salary" therein contained the following definition :—

" 'Salary' means the annual salary of an officer as approved by the Commissioner under the provisions of the Law, or where no such approval is required, the annual salary of an officer as may be appointed by the Council, plus, in each case, any cost-of-living allowance paid to an officer but so that in no case such allowance to exceed twelve and a half per centum of the salary of any such officer ".

3. Chapters 4, 5 and 6 and bye-laws 17 and 31 both inclusive of the principal Bye-laws are hereby repealed and the following chapters and bye-laws substituted therefor :—

*“Chapter 4.—Meat Market.*

17. The shops situated in the municipal market under numbers 16 to 19 and 23 to 27, inclusive, are hereby provided and shall henceforth be used as a public meat market :

Provided that the Council may, for such period and on such terms and conditions as the Council may from time to time determine, let on hire the shops situated in the meat market.

18. No person shall sell or expose for sale within the municipal limits any meat, except at the meat market :

Provided that the Council may grant, for such period and on such terms and conditions as the Council may from time to time determine, a permit to any person to sell or expose for sale in any specified premises in or outside the municipal market any frozen meat and may revoke such permit at any time after giving notice in writing of thirty days therefor to the person in the name of whom the permit was issued.

19. No person shall bring or cause to be brought into the meat market :—

- (a) any pork, whether fresh, frozen or dry, or
- (b) any preparation made of the flesh of any swine.

20. The following fees shall be paid by any person selling or exposing for sale frozen meat within the municipal limits, that is to say for each oke of frozen meat or part thereof a fee of 15 mils.

21. In this Chapter of these bye-laws :—

- (a) the term ‘meat’ shall include both fresh meat and frozen meat ;
- (b) the term ‘fresh meat’ includes fresh meat but does not include frozen meat or meat imported, preserved in cans or cases ;
- (c) the term ‘frozen meat’ includes only frozen meat.

*Chapter 5.—Pork Market.*

22. The shop situated in the municipal market under number 20 is hereby provided and shall henceforth be used as a public pork market :

Provided that the sheds, stalls and stands situated in the pork market may be let on hire by the Council for such period and on such terms and conditions as the Council may from time to time determine :

Provided further that no other goods or meat except pork shall be exposed for sale in the pork market.

23. No person shall sell or expose for sale within the municipal limits any pork except at the pork market :

Provided that the Council may grant, for such period and on such terms and conditions as the Council may from time to time determine, a permit to any person to sell or expose for sale in any specified premises in or outside the municipal market any frozen pork and may revoke such permit at any time after giving notice in writing of thirty days to the person in the name of whom the permit was issued.

24. The following fees shall be paid by any person selling or exposing for sale frozen pork within the municipal limits, that is to say for each oke of frozen pork or part thereof a fee of 15 mils.

25. In this Chapter of these bye-laws—

- (a) the term ‘pork’ includes fresh pork, fresh carcass of a swine and frozen pork ;
- (b) the term ‘fresh pork’ includes only fresh pork or the fresh carcass of a swine, but does not include frozen pork or pork imported, preserved in cans or cases ;
- (c) the term ‘frozen pork’ includes only frozen pork.

*Chapter 6.—Fish Market.*

26. In this Chapter of these bye-laws :—

- (a) the term 'fish market' means the shop situated in the municipal market under No. 22 ;
- (b) the term 'fish' shall include both fresh fish and frozen fish ;
- (c) the term 'fresh fish' includes fresh fish, but does not include frozen fish or fish imported, preserved in cans or cases.

27. Save as in bye-law 28 of these bye-laws provided no person shall sell or expose for sale within the municipal limits fish except only in the fish market :

Provided that the Council may grant, for such period and on such terms and conditions as the Council may from time to time determine, a permit to any person to sell or expose for sale in any specified premises in or outside the municipal market any frozen fish and revoke such permit at any time after giving notice in writing of thirty days to the person in the name of whom the permit was issued.

28.—(1) No person shall hawk for sale or shall expose for sale within the municipal limits outside the fish market fresh fish :—

- (a) except between such hours as may from time to time be prescribed by the mayor ;
- (b) unless such fresh fish has been previously exposed for sale in the fish market ; and
- (c) unless such fresh fish is exposed for sale in proper cabinets, boxes, utensils, or other means of conveyance to the satisfaction of the Sanitary Authority or the Inspector.

(2) All such cabinets, boxes, utensils or other means of conveyance shall be kept closed except when temporarily opened for the purpose of withdrawing the contents or part thereof, or of stocking them with new material.

29. All fish sold or exposed for sale within the municipal limits which in the opinion of the Sanitary Authority or the Inspector is unfit for human consumption may be seized and detained by the Sanitary Authority or the Inspector and may be destroyed or otherwise disposed of as the Mayor may direct in writing.

30. Fish exposed for sale in the fish market or within the municipal limits shall not be sold otherwise than by weight, and every person exposing such fish for sale therein shall provide himself with proper and correct weights, scales, balances or other apparatus to the satisfaction of the Inspector.

31.—(1) The following fees shall be paid by every person exposing for sale fish in the fish market or within the municipal limits under the provision of bye-laws 27, 28 and 29 hereinbefore, that is to say for every oke of such fish or any part thereof a fee of 15 mils.

(2) The fees in this bye-law prescribed shall be paid to the Inspector."

4. Bye-law 238 of the principal Bye-laws is hereby amended by the substitution for the words "yearly pay" appearing in paragraph (1) of such bye-law of the word "salary".

5. Bye-laws 2 and 238 as amended shall be deemed to have come into operation on the 1st day of January, 1960.
