Rules made by the Village Health Commission of Trakhonas under Section 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, Cap. 142, the Village Health Commission of Trakhonas hereby make the following Rules:—

- 1. These Rules may be cited as the Village Health (Trakhonas) (Amendment) Rules, 1960, and shall be read as one with the Village Health (Trakhonas) Rules, 1940 to 1959 (hereinafter referred to as "the principal Rules") and the principal Rules and these Rules may together be cited as the Village Health (Trakhonas) Rules, 1940 to 1960.
- 2. Rule 20 (i) of the principal Rules is hereby repealed and substituted by the following Rule:—
 - "Rule 20 (i). The following fees shall be paid by the owner of, or the person slaughtering, any animal in a slaughter-house, that is to say:—
