

No. 176. THE PUBLIC HEALTH (VILLAGES) LAW.
CAP. 142.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF TRAKHONAS
UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, Cap. 142, the Village Health Commission of Trakhonas hereby make the following Rules :—

1. These Rules may be cited as the Village Health (Trakhonas) (Amendment) Rules, 1960, and shall be read as one with the Village Health (Trakhonas) Rules, 1940 to 1959 (hereinafter referred to as "the principal Rules") and the principal Rules and these Rules may together be cited as the Village Health (Trakhonas) Rules, 1940 to 1960.

2. Rule 20 (i) of the principal Rules is hereby repealed and substituted by the following Rule :—

"Rule 20 (i). The following fees shall be paid by the owner of, or the person slaughtering, any animal in a slaughter-house, that is to say :—

	<i>Mils</i>
(a) For every kid or lamb not exceeding six okes in weight	250
(b) For every goat, kid, lamb or sheep exceeding six okes in weight	100
(c) For every bullock, camel, cow or ox not exceeding thirty okes in weight	150
Exceeding thirty okes in weight but not more than sixty okes	250
Exceeding sixty okes in weight	300"

The above Rules have been approved by the Commissioner of Nicosia and Kyrenia.

THE STREETS AND BUILDINGS REGULATION LAW.

CAP. 165 AND LAWS 10 OF 1950, 44 OF 1954, 18 OF 1955,
12 OF 1957 AND 14 OF 1959.

NOTICE UNDER SECTION 17 (7).

With reference to the notice published under No. 1309 in the *Gazette* of 24th December, 1959, it is hereby notified for general information that, after considering the plans and specifications concerning all the streets set out in the Schedule to the aforementioned notice, no objections having been made, the Governor, with the advice of the Executive Council, has been pleased to approve the plans and specifications concerning the streets enumerated under column (1) to the extent shown under column (2) of the Schedule hereto.

2. The plans and specifications in respect of the streets set out in the Schedule hereto shall, subject to the conditions shown under column (2)

of the Schedule, be binding on the appropriate authority for the area of the Municipal Corporation of Famagusta and upon all owners affected.
