## THE LAND ACQUISITION LAW.

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

## NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 162 of 1960, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein : —

All those areas of privately-owned land with everything standing thereon, situated at Shakespeare Street and the continuation thereof from the Municipal Boundaries along the Pedieos river to the Nicosia—Kyrenia Main Road, in the town of Nicosia and in the village of Orta Keuy, in the District of Nicosia, comprising four donums or thereabouts, being : —

(a) *In the town of Nicosia :*

Parts of plots Nos. 280, 16, 17, 20, 19, 22, 294, 305, 306, 319, 244, 239, 240, 292, 286, 222, 218, 9, 10, 11, 12, 13 and 14 of Block A, Arab Ahmed Quarter.

(b) *In the village of Orta Keuy :*

Parts of plots Nos. 300, 128, 129, 131, 224, 225, 226, 239, 252, 253, 273, 274, 281, 290, 196, 197, 212, 211, 210, 209, 208, 207, 205, 206, 153, 326, 329, 330, 331, 137, 533, 532, 531 and 530 of Block D, Orta Keuy.

All which said land is more particularly defined as the areas coloured yellow on the plan signed by the Chief Engineer, Public Works Department, and dated the 7th June, 1960.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition, is required within ten days from the date of the publication of this notice to send to me a statement of his right and interest and the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said land.

4. The plan mentioned above is available for inspection at my office.

5. The period mentioned in paragraph 2 hereof has been abridged to ten days with the approval of His Excellency the Governor.
