APPOINTMENT OF RETURNING OFFICERS UNDER SECTION 8 (1).

In exercise of the powers vested in him by sub-section (1) of section 8 of the Elections (House of Representatives and Communal Chambers) Laws, 1959 and 1960, His Excellency the Governor has been pleased to appoint the persons specified in the first column of the Schedule hereto, to be Returning Officers for the Turkish constituencies specified in the second column of the said Schedule for the purpose of the election of the Turkish Members of the House of Representatives and of the election of Members of the Turkish Communal Chamber.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CONTINUATION) LAWS, 1958 AND 1959.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor, by this Order, orders as follows :—

1. Subject to the restrictions and conditions contained in the First Schedule to this Order, the use, for military purposes, of the land specified in the Second Schedule (hereinafter referred to as "the land") during the period of two years from the date of this Order is hereby authorized.

2. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for such military purposes.

3. The exercise of any right of way over the land and of any right relating thereto which is enjoyed by any person, whether by virtue of any interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

FIRST SCHEDULE.

1. The land shall be occupied and used for military purposes only.

2. At the expiration of this Order the land shall be returned to the persons entitled thereto free of any erection, structure or construction erected or constructed thereon after the making of this Order.

3. Compensation shall be paid to the persons having an interest in the land for its use and occupation under this Order.

SECOND SCHEDULE.

The following areas of land and everything standing thereon and therein, situated in the villages of Kolossi and Episkopi, in the District of Limassol, that is to say—

(a) an area of land sixty feet wide in the villages of Kolossi and Episkopi, being—

(i) in the village of Kolossi, at the localities “Ayios Stephanos”, “Phinidji”, “Vounarkotissa”, “Appis”, “Ammo Tepesi” and “Stouppoudhia”, parts of plots Nos. 11, 10/3, 10/4, 9/3, 9/4, 8, 16, 17, 21/1, 1 and 22/3 of the Government Survey Plan No. LVIII.14, parts of plots Nos. 109, 110, 111 and 112 of the Government Survey Plan No. LVIII.13 and parts of plots Nos. 198/3/1, 198/3/2, 336.1 and 336.2 of the Government Survey Plan No. LVIII.6;

(ii) in the village of Episkopi, at the localities “Atovounos”, “Episkopi Forest”, “At Meydani”, “Tapakhanou”, “Ayios Armoyenis”, “Injirlik”, “Marathkes”, “Karavkia”, “Kourka” and “Stouppoudhia”, parts of plots Nos. 6/2/1, 6/1/1, 5/1/1, 43/1, 44/1, 38/1, 35/1, 63, 66, 64, 65, 88 and 93 of the Government Survey Plan No. LVIII.4, parts of plots Nos. 131/1, 132, 133, 134, 135, 136, 138, 139/2, 139/1, 142/2 and 142/1 of the Government Survey Plan No. LVIII.5, parts of plots Nos. 12/3, 98, 97, 96, 95, 105/5 and 105/4 of the Government Survey Plan No. LVIII.13;

required for the purpose of laying, using and maintaining a water pipeline together with valves, washouts and control cables, in, over or under the lands aforesaid and for the purpose of providing passage of vehicles and pedestrians during the period of construction and testing thereof; all which said area is more particularly defined as the area within a distance of thirty feet from, and on either side of, the line coloured red on the Plan No. 135 signed by the Deputy Assistant Director of Lands, Limassol, and dated the 22nd June, 1960;

(b) the areas of land situated at the localities “Ayios Nicolas”, “Ayios Stephanos” and “Phinidji” in the village of Kolossi, being parts of plots Nos. 198/3/1 and 198/3/2 of the Government Survey Plan No. LVIII.6 and parts of plots Nos. 10/3 and 11 of the Government Survey Plan No. LVIII.14, required for the purpose of maintaining four boreholes and more particularly defined as the areas coloured red on the Plan No. 135 signed by the Deputy Assistant Director of Lands, Limassol, and dated the 22nd June, 1960;

(c) the area of land situated at the locality “Ammo Tepesi” in the village of Kolossi, being part of plot No. 109 of the Government Survey Plan No. LVIII.13, required for the purpose of constructing a control house and water tanks and more particularly defined on the area hatched red on the Plan No. 135 signed by the Deputy Assistant Director of Lands, Limassol, and dated the 22nd June, 1960;

(d) the areas of land fifteen feet wide situated at the localities “Appis”, “Ayios Nicolas” and “Ayios Stephanos” in the village of Kolossi, being parts of plots Nos. 336.2, 198/1, 198/3/1, 198/3/2 and 199 of the Government Survey Plan No. LVIII.6 and parts of plots Nos. 1, 10/2, 10/3 and 11 of the Government

Survey Plan No. LVIII. 14, required for the purpose of providing access tracks for the passage of vehicles and pedestrians and more particularly defined as the areas coloured brown on the Plan No. 135 signed by the Deputy Assistant Director of Lands, Limassol, and dated the 22nd June, 1960.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by the Orders dated as shown in the first column of the Schedule hereto and published as Public Instruments as shown in the second column of the said Schedule (hereinafter referred to as "the Orders"), the Governor authorised the use of the land and property specified in the Orders subject to the restrictions and conditions therein contained for military purposes during periods of six months ;

And whereas the Orders were extended from time to time by the Public Instruments shown in the third column of the Schedule ;

And whereas the Governor is satisfied that the land and property should continue to be used for military purposes for further periods :

Now, therefore, in exercise of the powers conferred upon him by Defence Regulation 64 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorised the use of the land and property specified in the Orders and subject to the restrictions and conditions therein contained for the further periods shown in the fourth column of the Schedule hereto.
