NOTICE UNDER SECTION 7.

Whereas by Notification No. 491 published in Supplement No. 3 to the *Gazette* of the 30th October, 1959, the Governor declared the construction of roads in the vicinity of Dhekelia, Akhna and Episkopi to be an undertaking of public utility ;

And whereas the Commissioner of Limassol, by a notice published under Notification No. 117 in Supplement No. 3 to the *Gazette* of the 12th April, 1960, gave particulars of the lands (hereinafter referred to as the "lands") required in connection with the aforesaid undertaking ;

And whereas the Commissioner of Limassol forwarded to the Governor the required recommendations, plan and particulars, together with the objections made ;

And whereas the Governor has approved the plan and particulars submitted, and has considered it expedient, having regard to all the circumstances of the case, that the lands should be acquired :

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor hereby sanctions the acquisition under the provisions of the said Law, of the lands.

No. 229. THE FORESHORE PROTECTION LAW.
CAP. 92 AND LAWS 16 OF 1954 AND 21 OF 1957.

NOTICE UNDER SECTION 3 (1).

In exercise of the powers vested in me by section 3 (1) of the Foreshore Protection Law, I hereby absolutely prohibit—

(a)—(i) the dumping of any rubble, rubbish, sweepings, litter, night-soil or any other refuse from any pier, wharf, quay or jetty, situated within the District of Famagusta;

(ii) the dumping of any rubble, rubbish, sweepings, litter, night-soil or other refuse upon any part of the areas of the foreshore described in the Schedules hereto ;

(iii) the dumping of any rubble, rubbish, sweepings, litter, night-soil or other refuse into the sea at any point opposite to the foreshore described in the Schedules hereto within a distance of 200 yards from low-water mark ;

(b) the removal of any stones, shingle, gravel, sand or other substances from any part of the areas of the foreshore described in the Schedules hereto,

save under a permit from me previously obtained.

2. Any previous notices issued by me and published in the *Gazette* P.I. under the said Law are hereby cancelled.

SCHEDULE 1.
FAMAGUSTA TOWN.

The foreshore commences at a point on the seashore which point is due east of the south-eastern corner of plot No. 158 of Block "F" of Ayios Memnon quarter, locality "Dromos tou Xenti" and proceeds in a northerly direction along the high-water mark to the Famagusta pier, and includes any land within a distance of 50 yards of the said high-water mark throughout its length.

SCHEDULE 2.
AYIOS SERGIOS VILLAGE.
Area "A".

The foreshore commences at a point on the seashore which point is due east on the most northern point of plot No. 151 of Government Survey Plan XXIV.26 locality "Lourna" and proceeds south-eastwards along the high-water mark to a point due to the most eastern point of plot No. 8.1 of Government Survey Plan XXIV.43 west, locality "Katalimata" and includes any land within a distance of 50 yards of the said high-water mark throughout its length.

Area "B".

The foreshore commences at the south-eastern corner of Plot No. 30 of the Government Survey Plan XXIV.19, locality "Sheromilia" which corner is on the sea-shore and proceeds northwards along the high-water mark for a distance of 3,226 yards or thereabouts to the most northern point of the said plot, and includes any land within a distance of fifty yards of the said high-water mark throughout its length.

SCHEDULE 3.
TRIKOMO VILLAGE.

The foreshore commences at a point on the sea-shore, which point is due east of the north-eastern corner of plot 122 of the Government Survey Plan XV.59, locality "Haravdi" and proceeds north-eastwards along the high-water mark for a distance of 1,433 yards or thereabouts to a point due east of the north-eastern corner of plot 108 of the said plan, and includes any land within a distance of fifty yards of the said high-water mark throughout its length.

SCHEDULE 4.
TRIKOMO AND BOGHAZ VILLAGES.

The foreshore commences at a point on the sea-shore which point is due east of the north-eastern corner of plot 95 of the Government Survey

Plan XV.51, locality "Komma" and proceeds north-eastwards along the high-water mark to the Boghaz jetty, and includes any land within a distance of fifty yards of the said high-water mark throughout its length.

The said areas described in Schedule 1, Area "A", and Schedules 2, 3 and 4 are more particularly defined as the areas coloured yellow on the Government Survey Plan Serial No. 1623 and the area described in Schedule 1, Area "B", is more particularly defined as the area coloured yellow on the Government Survey Plan Serial No. 1628 copies of both of which are available for inspection at the office of the Commissioner, Famagusta.
