NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 466 of 1956, notice is hereby given that the following lands are required to be acquired for the undertaking of public utility mentioned therein : —

All those areas of privately-owned lands with everything standing thereon, situated at the locality "Livadhia" in the town of Morphou, in the District of Nicosia, comprising 1 donum and 1,500 square feet or thereabouts, forming parts of plots Nos. 8, 22 and 407 of Block J, Ayios Mamas Quarter, and more particularly defined as the areas coloured red on the plan signed by the Acting Chief Water Development Officer and dated the 25th June, 1960.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition thereof is required within six weeks of the date of the publication of this notice to send to me a statement of his right and interest and the evidence thereof and of any claim made by him in respect of such right and interest.

3. The Governor is willing to treat for the acquisition of the said lands.

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 466 of 1956, notice is hereby given that the following lands are required to be acquired and the following easements, privileges and liberties are required to be created and acquired for the undertaking of public utility mentioned therein :—

- (i) All those areas of privately-owned land with everything standing thereon, situated at the localities "Livadhia" and "Arnaoutidhes" in the village of Prastio, in the District of Nicosia, comprising 3 donums and 900 square feet or thereabouts, forming parts of plots Nos. 71, 72, 73, 74, 75, 76, 82, 168 and 171 of Block E, Ay. Yeorghios Quarter and part of plot No. 23 of Block C, New Livadhhi Quarter, more particularly defined as the areas coloured red on the plan signed by the Acting Chief Water Development Officer and dated the 25th June, 1960.
- (ii) Easements, privileges and liberties for the purpose of laying, using and maintaining a water pipeline in, over or under the following privately-owned lands situated at the localities "Variyi" and "Baraji" in the village of Prastio, in the District of Nicosia, being plots Nos. 5, 10, 11, 12, 71, 74 and 75 of Block C, New Livadhhi Quarter, and plots Nos. 114, 115, 117, 154, 156, 157, 158, 1959 and 162 of Block E, Ay. Yeorghios Quarter; the route of which said pipeline is more particularly defined as the line coloured red on the plan signed by the Acting Chief Water Development Officer and dated the 25th June, 1960.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition thereof or to the creation and acquisition of the said easements, privileges and liberties is required within six weeks of the date of the publication of this notice to send to me a statement of his right and interest and the evidence thereof and of any claim made by him in respect of such right and interest.

3. The Governor is willing to treat for the acquisition of the said lands, easements, privileges and liberties.
