With reference to Public Instrument No. 466 of 1956, notice is hereby given that the following lands are required to be acquired and the following easements, privileges and liberties are required to be created and acquired for the undertaking of public utility mentioned therein :—

- (i) All those areas of privately-owned land with everything standing thereon, situated at the localities "Variyi" and "Gonia" in the village of Ghaziveran, in the District of Nicosia, comprising 1 donum and 1,200 square feet or thereabouts, forming parts of plots Nos. 73, 78 and 246 of Block C, and more particularly defined as the areas coloured red on the plan signed by the Acting Chief Water Development Officer and dated the 25th June, 1960.
