

## No. 283. THE LAND ACQUISITION LAW.

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

## NOTICE UNDER SECTION 6.

With reference to Notice under Sections 2, 3 and 5 of the above Laws published under Notification No. 13 of Supplement No. 3 of the *Gazette* of the 14th January, 1960, notice is hereby given that easements, privileges and liberties are required to be created and acquired for the undertaking of the public utility mentioned therein as follows:—

For the purpose of the laying, using and maintaining of a water pipe line (including the provision of valve and/or other chambers (hereinafter referred to as "valve chambers" and marker beacons) in, over or under the following privately-owned lands, situated in the villages of Kissousa, Mallia, Pakhna, Dhora, Anoyira, Evdhimou, Paramali and Sotira in the District of Limassol:—

The route of the said water pipeline is more particularly defined as the line coloured red on the plans signed by the Assistant Director of Lands, Cyprus, and dated the 30th July, 1960.

All references to easements, privileges and liberties in Public Instrument No. 14 of 1960, and the whole of sub-paragraphs (ii) and (iii) of the first paragraph thereof, are hereby cancelled.

2. Any person claiming to have any right or interest in the said lands who objects to the creation and acquisition of the said easements, privileges and liberties, is required within ten days from the date of the publication of this notice to send me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said easements, privileges and liberties.

4. The plans mentioned above are available for inspection in my office.

5. The period mentioned in paragraph 2 hereof has been abridged to ten days with the approval of His Excellency the Governor.
