DECLARATION OF ELECTION OF CANDIDATES UNDER SECTION 17.

Whereas by section 17 of the Elections (House of Representatives and Communal Chambers) Law, 1959 and 1960, it is, *inter alia*, provided that if as the result of a candidate withdrawing his candidature under the provisions of section 14 at any time after nomination and prior to the day of the poll, the number of candidates standing nominated is equal to or is less than the number of seats to be filled, the Returning Officer shall forthwith declare the nominated candidates to be elected and cause the names of the persons so elected to be published in the *Gazette* ;
