**BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF
LIMASSOL.**

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Limassol hereby make the following bye-laws :

1. These bye-laws may be cited as the Limassol Municipal (Amendment No. 2) Bye-laws, 1960, and shall be read as one with the Limassol Municipal Bye-laws, 1953 to 1960 (hereinafter referred to as " the principal bye-laws ") and the principal bye-laws and these bye-laws may together be cited as the Limassol Municipal Bye-laws, 1953 to 1960.

2. Bye-law 188 of the principal bye-laws is hereby repealed and the following bye-law substituted therefor :

" 188. No person, without the consent or authority of the Mayor previously obtained, shall within the limits of any of the Municipal Gardens of Limassol :

- (a) lead, ride, drive or take any animal (including a dog), bicycle, tricycle or any vehicle whatsoever, provided that the prohibitions contained in this paragraph (a) shall not apply to perambulators pushed by pedestrians ;
- (b) play any game in any place of such Municipal Gardens not specially reserved by the Council for the playing of games ; or play any game in any place of such Municipal Gardens not specially reserved by the Council for the playing of such game ;
- (c) enter any place of such Municipal Gardens the entrance to which is prohibited by the Council or the Mayor ;
- (d) cut, destroy, damage or injure or cause or allow or suffer to be cut, destroyed, damaged or injured any plants, trees, flowers, hedges, buildings, benches or other parts of such Municipal Gardens or other property of the Municipal Corporation ;
- (e) throw, deposit, leave or suffer to be thrown, deposited or left any refuse in any place other than in the receptacles for refuse provided by the Council ;

- (f) hawk about for sale or sell any goods or other things whatsoever or carry out the business of a photographer or any other business whatsoever, provided however, that the Mayor shall be entitled to grant licences and permits for all or any of the purposes aforesaid and attach to such licences or permits such terms and conditions including the payment of fees as to him may seem necessary or desirable and suspend or revoke such licences and permits when he considers it advisable so to do ;
- (g) use any of the playing equipment intended for the use of children if such person is over 12 years of age, or enter the playing grounds reserved for children if such person, whether male or female, is over 18 years of age, unless such person accompanies any child therein ”.
3. The principal bye-laws are hereby amended by the insertion immediately after bye-law 188 of the following bye-laws :
- “ 188A. No person, without the consent or authority of the Mayor previously obtained shall :
- (a) enter or remain in any of the Municipal Gardens of Limassol at any hours during which the entrance of the public to the said Municipal Gardens is prohibited by the Mayor ;
- (b) enter the said Municipal Gardens through any place other than any of their entrance gates ”.
- 188B. Any coffee-shops, bars or kiosks situated within any of the said Municipal Gardens shall not, without the consent or authority of the Mayor previously obtained, be open or operate at any hours during which the entrance of the public to the said Municipal Gardens is prohibited by the Mayor.
- 188c. No person shall within the limits of any of such Gardens :
- (a) throw any thing at or annoy the animals or birds kept by the Council in such Municipal Gardens ;
- (b) shoot whether by gun, air rifle or catapult or by any other means any birds or animals whether kept by the Council in such Gardens or otherwise found therein.
- 188D. No teacher or other person shall, without the consent, authority or permit of the Mayor previously obtained, lead any pupils or students into any of such Gardens. The Mayor may in giving such consent, authority or permit for such purpose attach to it such terms and conditions as to him may seem necessary or desirable.
- 188E. The Council may establish a Zoo within the limits of any of such Gardens and fix fees for entrance thereto and alter such fees from time to time ”.

The above bye-laws have been approved by His Excellency the Governor.
