**No. 7. THE MUNICIPAL CORPORATIONS LAW.
CAP. 252 AND LAWS 11 OF 1950, 31 OF 1951, 20 OF 1953, 29 OF 1954
57 OF 1954 AND 14 OF 1955.**

BYE-LAWS MADE BY THE MUNICIPAL COMMISSION OF NICOSIA

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Municipal Commission of Nicosia hereby make the following bye-laws:—

1. These bye-laws may be cited as the Municipal Corporation (Nicosia) Pensions and Gratuities (Amendment) (No. 2) Bye-laws, 1959, and shall be read as one with the Municipal Corporation (Nicosia) Pensions and Gratuities Bye-laws, 1930 to 1959 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Nicosia) Pensions and Gratuities Bye-laws, 1930 to 1959.

2. Paragraph 3 (as set out in the Municipal Corporation (Nicosia) Pensions and Gratuities (Amendment) Bye-laws, 1959), and published under Public Instrument No. 454 of 1959 is hereby amended by the deletion therefrom of the year 1959, and the substitution therefor of the year 1957.

The above Bye-laws have been approved by His Excellency the Governor.
