SCHEDULE.

All that area of land situated at the villages of Yermasoyia, Moutayiaka and Ayios Tykhonas, lying within the following boundary, that is

to say:

The boundary commences at the most southern point of plot No. 1 of the Government Survey Plan No. LIV/53, which point is on the boundary between the villages of Moutayiaka and Yermasoyia and proceeds northwards and westwards along the said boundary to the most southern point of plot No. 456 of the Government Survey Plan No. LIV/44; thence north-westwards in a straight line to the point on the northern boundary of plot No. 445 of the said plan where it is cut by the straight line from the said point to the northwestern corner of plot No. 250 of the said plan; thence eastwards along the boundaries of and including part of plot No. 445 of the said plan, part of plot No. 72 of the Government Survey Plan No. LIV/52, plots Nos. 450, 451, 452, 456 and 521 of the Government Survey Plan No. LIV/44, to the north-eastern corner of the last-mentioned plot, which corner is on the Limassol-Moutayiaka village road; thence in a north-easterly direction along the said road to its junction with a footpath; thence in an easterly direction along the said footpath to its junction with a track leading from Moutayiaka village to the Limassol-Avios Tykhonas village road; thence eastwards along the said track to its junction with the said road; thence north-eastwards along the said road to the most northern point of plot No. 228 of the Government Survey Plan No. LIV/45; thence in an easterly direction along the boundaries of and including the said plot, plots Nos. 231, 232, 234, 235, 236 and 217 of the said plan, plots Nos. 10, 11, 36, 34, 28, 29, 119, 120, 132 and 133 of the Government Survey Plan No. LIV/46, to the most northern point of the last mentioned plot, locality "Exokastrou"; thence in a southerly direction along the boundaries of and including the said plot, plots Nos. 130, 129 and 128 of the said plan, to the south-eastern corner of the last mentioned plot, which corner is on the Limassol-Nicosia main road; thence in a northeasterly direction along the said main road to the north-eastern corner of plot No. 223 of the said plan, locality "Kokkinoyia"; thence southwards and westwards along the boundary of the said plot to the sea-shore; thence in a south-westerly direction along the said seashore to the point of commencement, all which said boundary is shown edged green on the Government Survey Plan Serial No. 1728, a copy of which is deposited in the office of the Commissioner, Limassol.

THE PUBLIC HEALTH (VILLAGES) LAW. CAP. 142.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF KATO DHEFTERA IN THE DISTRICT OF NICOSIA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Kato Dheftera hereby make the following rules:—
1. These rules may be cited as the Village Health (Kato Dheftera) Rules, 1960, and shall come into operation on their publication in the Gazette.

2.-(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Nikos) Rules, 1952, published in the Gazette of the 19th November, 1952, shall-

(a) be deemed to be rules made by the Village Health Commission of Kato Dheftera and to

be incorporated herein, and
(b) apply to the village of Kato Dheftera.

(2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding

rules of the Village Health (Nikos) Rules, 1952.

(3) Those rules of the Village Health (Nikos) Rules, 1952, mentioned in Part II of the Schedule hereto, shall not apply to the village of Kato Dheftera.

SCHEDULE. PART I. (Rule 2 (2).)

RULES TO BE SUBSTITUTED.

Rule 2. In these rules, unless the context otherwise requires, the following terms have the meanings respectively assigned to them, that is to say: "animal", save when in any part or chapter of these rules otherwise defined, means any ass, camel, cow, goat, horse, kid, lamb, mule, ox, sheep or swine; "bakery" means any premises or place used for preparing or making or baking bread

for sale to the public;
"Commission" means the Village Health Commission of the village of Kato Dhestera; "Commissioner" means the Commissioner of the District of Nicosia and includes any person who at any time is lawfully discharging the duties of the Commissioner of the

District of Nicosia;

"fresh meat" means the fresh meat of any animal;
"household refuse" means any ashes, dung, dust, filth, paper, rubbish or any other

waste matter; "inspector" means an inspector appointed by the Commission for the purpose of the part

or chapter of these rules in which the word occurs;

"khan" includes any room or place used as a khan or in connection therewith;

"Medical Officer" means the District Medical Officer of Nicosia or his representative and includes any registered medical practitioner or other person authorized or appointed by the Director of Medical Services for the purposes of these rules;

premises" means any building, structure, hut, shop, tent, land or place situated within

the area of the village;
"public notification" means a notification signed by the Chairman of the Commission

and posted in at least two conspicuous places within the area of the village;
"sanitary convenience" includes any urinal, privy or cesspit;
"street" includes any square, road, bridle-path, pathway, blind-alley, passage, footway, pavement or public place situated within the area of the village;
"village" means the village of Kato Dheftera.

Rule 19. The following fees shall be paid by the owner of or the person slaughtering any animal in the slaughter-house, that is to say :-

(2) The fees in paragraph (1) of this rule prescribed shall not be payable by any person exposing for sale any fresh meat in the meat market, who is a monthly or yearly lessee of any shop, stall or place in the meat market under rule 45 of these rules.

Rule 53.—(1) The following fee shall be paid by the owner of or the person exposing for sale any carcass of swine or fresh pork in the pork market, that is to say, for every carcass of swine or part thereof or portion of fresh pork, one hundred mils (0.100 mils).

(2) Every such fee shall be paid to the inspector.

Rule 56.—(1) The following fees shall be paid by every person exposing for sale any foodstuffs in the market of foodstuffs, that is to say:-

Rule 63. The rent to be paid for the erection or letting on hire of a booth in the fair market shall be from 250 mils to 2.000 mils, according to the size and position of the booth, to be determined in each case by the inspector.

Rule 64. The following fees shall be paid by every person selling or exposing for sale in the fair market the following animals, goods, articles, things, eatables or liquids of any kind, that is to say:—

(d) For any kind of goods, articles, things, eatables or liquids exposed for sale for the whole or any part of the period of the said fair, a fee from 25 mils to 1.000 mils according to the value or quantity thereof, to be determined in each case by the inspector.

Rule 86. The following fee shall be paid by the owner or occupier of any premises for the removal by persons appointed by the Commission of buckets or receptacles containing household refuse or manure within the area of the village, that is to say:—

For every bucket or receptacle of household refuse or manure for a period

of one year or part thereof 1.000 mils.

Rule 94. There shall be paid by every occupier in the village in every year a rate not exceeding £10 to be assessed by the Commission according to the means within the area of the village of each such occupier.

Rule 95. The Commission shall on or before the 1st day of July in each year prepare a list (hereinafter in this part of these rules referred to as "the Occupiers' List"), showing the name, occupation and place of abode of every occupier in the village and the amount of the annual rate assessed on each such occupier. The Occupiers' List shall be dated and signed by the Chairman of the Commission.

Rule 99. Every occupier in the village whose name appears in the Occupiers' List shall, on or before the 15th day of October, pay to the Chairman of the Commission or to such other person as may be appointed Treasurer by the Commissioner, the amount of the annual rate assessed on such occupier.
