In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, Cap. 111, the following Rules made by the Committee of the Irrigation Division of Mora, in the District of Nicosia, are published in the *Gazette*.

Gazette: Supplement No. 3: 7.5.1937. These Rules may be cited as the Irrigation Division of Mora (Amendment) Rules, 1960, and shall be read as one with the Irrigation Division of Mora Rules, 1937 (hereinafter referred to as "the principal Rules") and the principal Rules and these Rules may together be cited as the Irrigation Division of Mora Rules, 1937 to 1960.

2. Rule 4(a) of the principal Rules is hereby amended by the deletion thereform of the words "July and August" and the substitution therefor of the words "August and September".

3. Rule 4(b) of the principal Rules is hereby amended by the deletion therefrom of the word "September" and the substitution therefor of the word "October".

4. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "six shillings" and the substitution therefor of the words "one thousand mils".

5. Rule 6 of the principal Rules is hereby amended by the deletion therefrom of the words "31st August" and the substitution therefor of the words "30th September".
