ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 26th May, 1958, and published as Public Instrument No. 337 of 1958, hereinafter referred to as "the Order", the Governor authorized the use of the land and property specified in the Order subject to the restrictions and conditions therein contained for military purposes during the period of six months commencing the 26th May, 1958;

And whereas by virtue of Public Instruments Nos. 885 of 1958, 256 of 1959, 510 of 1959 and 60 of 1960, the Order was extended for further periods up to the 25th March, 1960;

And whereas the Governor is satisfied that the said land and property should continue to be used for military purposes for a further period of three months:

Now, therefore, in exercise of the powers conferred upon him by Defence Regulation 64 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorized the use of the land and property specified in the Order and subject to the restrictions and conditions therein contained for a further period of three months commencing the 26th March, 1960.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 9th January, 1956, and published as Public Instrument No. 16 of 1956, hereinafter referred to as "the Order", the Governor authorized the use of the land and property specified in the Order subject to the restrictions and conditions therein contained for military purposes during the period of six months commencing the 9th January, 1956;

And whereas by virtue of Public Instruments Nos. 640 of 1956, 1284 of 1956, 705 of 1957, 1112 of 1957, 1023 of 1958, 151 of 1959, 315 of 1959, 351 of 1959, 28 of 1960 and 60 of 1960, the Order was extended for further periods of six months up to the 12th March, 1960;

And whereas the Governor is satisfied that the said land and property should continue to be used for military purposes for a further period of three months:

Now, therefore, in exercise of the powers conferred upon him by Defence Regulation 64 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by

virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorized the use of the land and property specified in the Order and subject to the restrictions and conditions therein contained for a further period of three months commencing the 13th March, 1960.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATIONS 64 AND 102.

Whereas by Order dated the 21st September, 1956, and published under Public Instrument No. 946 of 1956 (hereinafter referred to as "the principal Order"), His Excellency the Governor has authorized the use for military purposes of the land and property set out in the Second Schedule of the principal Order, situated at Orta Keuy and Ayios Dhometios villages, Nicosia District (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 220 of 1957, 814 of 1957, 164 of 1958, 1010 of 1958, 159 of 1959, 396 of 1959, and 60 of 1960 the principal Order was extended for further periods up to the 5th March, 1960 ;

And whereas the Governor is satisfied that the land (excluding those parts specified in the Schedule hereto) should continue to be used for military purposes for a further period ending on the 5th June, 1960 :

Now, therefore, in exercise of the powers conferred upon him by Defence Regulations 64 and 102 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorized the use of the land (excluding those parts specified in the Schedule hereto) for military purposes subject to the restrictions and conditions laid down in the principal Order until the 5th June, 1960, as from the 6th March, 1960, and further has revoked that part of the principal Order which affects the property set out in the Schedule hereto, without prejudice to anything done or left undone thereunder, and the Second Schedule of the principal Order is hereby amended by the deletion therefrom of the plot numbers appearing in the Schedule hereto.

Plot Nos. 420, 421, 422, 423 and part of Plot Nos. 419, 85 and 1511, of the Government Survey Plans, Sheet XXI.37.E.1, Orta Keuy village (Block F) and XXI.37.E.2, Ayios Dhometios village (Block F).
