1. This Law may be cited as the Elementary Education (other than Greek-Christian) Amendment Law, 1924, and shall be read as one with the Elementary Education (other than Greek-Christian) Law, 1920, (hereinafter referred to as the Principal Law) and the Elementary Education (other than Greek-Christian) Amendment Law, 1923, and the Principal Law and the said Law and this Law may together be cited as the Elementary Education (other than Greek-Christian) Laws, 1920 to 1924.

Short title.

2. The Principal Law, section 57, is hereby repealed and in place thereof the following section shall have effect:—

Repeal of Law 24 of 1920, s. 57, and substitution of a new section.

57.—(1) To provide for the salaries of teachers and other items of expenditure under this Law there shall be formed a fund to be called the Education Fund. Such Fund shall consist of the following sums:—

(a) The annual taxes mentioned in Schedules A. and B. which shall be paid:

(1) by all persons not being members of the Greek-Christian community; and

(2) by all bodies of persons corporate or unincorporate not exempt from taxation under this Law and being bodies of persons the whole of whose members belong to the Moslem community.

(b) The sums declared by the High Commissioner to be payable to the Education Fund under the provisions of sub-section (2) hereof.

(c) The sum provided in the annual Appropriation Law for elementary schools under this Law.

(2) The annual taxes mentioned in Schedules A. and B. shall be paid by all bodies of persons corporate or unincorporate not being bodies of persons the whole of whose members belong either to the Moslem or Greek-Christian community; in such cases the High Commissioner shall decide in what manner the sums so paid shall be applied for elementary education in the Island.

(3) The High Commissioner in Council may by order suspend, in whole or in part, from a day to be named in such order, the collection of any of the taxes specified in any of the Schedules to this Law.

3. The Principal Law, section 67, is hereby amended by the deletion of the words "five per cent." and by the substitution therefor of the words "ten per cent."

Validation  
of acts.

4. Any act or thing done or omitted under the provisions of the Principal Law or any Law amending the same which would have been validly and properly done or omitted under the Principal Law or any Law amending the same if section 57 of the Principal Law had been as provided by this Law shall be deemed to be and to have been validly and properly done thereunder.

Short title.

1. 2. The Principal Law, section 62, is hereby repealed and in place thereof the following section shall have effect:—

62.—(1) To provide for the salaries of teachers and other items of expenditure under this Law there shall be formed a fund to be called the Greek-Christian Education Fund. Such Fund shall consist of the following sums:—

(a) The annual taxes mentioned in Schedules A. and B. which shall be paid:
