BE it enacted :--

1. This Law may be cited as the Port Regulation Short title. (Amendment) Law, 1925, and shall be read as one with the Port Regulation Law, 1879, (hereinafter referred to as the Principal Law), and the Principal Law and this Law may together be cited as the Port Regulation Laws, 1879 and 1925.

TO AMEND THE GAME AND WILD BIRDS LAW.

BE it enacted :--

1. This Law may be cited as the Game and Wild Birds Short title. Protection (Amendment) Law, 1925, and shall be read as one with the Game and Wild Birds Protection Law, 1922. (hereinafter referred to as the Principal Law), and the Principal Law and this Law may together be cited as the Game and Wild Birds Protection Laws, 1922 and 1925.

Repeal of Law 38 of 1922, sec. 2, and substitution of new section. Definitions.

2. The Principal Law, section 2, is hereby repealed and in place thereof the following section shall have effect :—

2. In this Law :-

"Game" means hares, pheasants, partridges, and francolins.

"Game bird" means any bird included in the term Game.

"Wild bird" means any undomesticated bird not included in the term Game.

3. The Principal Law, section 3 (4), is hereby repealed and in place thereof the following sub-section shall have effect :---

3.—(4) A license under this Law other than one granted under the provisions of section 5 (3) hereof shall commence on the 20th August and shall expire on the 31st March provided always that licenses issued in respect of the year expiring the 1st March, 1926, shall be good and valid up to and including the 31st March, 1926.

4. The Principal Law, section 5, is hereby repealed and in place thereof the following section shall have effect :—

5.—(1) No person shall from the 1st February to the 19th August, both days inclusive, in any year shoot, kill, take, sell or expose for sale or attempt to shoot, kill, or take game or wild birds.

(2) Provided that the High Commissioner in Council may order that within such areas as shall be specified in such order wild birds may be shot, killed or taken, or attempted to be shot, killed or taken, from the 1st February to the 31st March, both days inclusive, in any year.

(3) Provided also that the Commissioner of the District may by license under his hand authorize the shooting of crows, sparrows, thrushes, blackbirds, starlings, larks, beccaficos, bee-eaters, doves, hoopoes, golden orioles, pigeons, jackdaws, magpies, ravens and hawks between the 1st April and 15th June, both days

inclusive. Every such license shall state the name of the person to whom it is granted, and the period during which and the place at which the person holding the license may shoot such wild birds as aforesaid.

(4) Wild birds shot in pursuance of the provisions of sub-sections 2 and 3 hereof may be sold.

(5) Except in pursuance of a license under sub-section 3 hereof mentioned or in furtherance of his official duties no person shall between the 1st April and 19th August, both days inclusive, carry a gun provided always that the Commissioner of the District may by license under his hand authorize the carrying of a gun for a specified purpose on an occasion of particular urgency.

(6) Provided also that during any period of the year crows, sparrows, thrushes, blackbirds, starlings, larks, beccaficos, bee-eaters, doves, hoopoes, golden orioles, pigeons, jackdaws, magpies, ravens and hawks may be snared, limed, captured or destroyed and sold in any manner.

5. The Principal Law, section 6, is hereby amended by the addition thereto of the following words :--

"Any person convicted of an offence under this section shall be liable to be imprisoned for a term not exceeding three months."

6. The Principal Law, section 7, is hereby repealed.

7. The Principal Law, section 16, is hereby amended by the addition thereto of the following words:—

"Any person convicted of an offence under this section shall be liable to be imprisoned for a term not exceeding three months."

8. The Principal Law, section 21, is hereby repealed and Repeal of in place thereof the following section shall have effect:— 1092 sec

21. Any person committing or attempting to commit any breach of this Law for which no specific penalty has been otherwise provided shall be liable :—

(a) For a first offence, to a fine not exceeding five pounds, and to have his license forfeited and to be prohibited from carrying a gun for a period of twelve months from the date of conviction.

(b) For a second and every other offence, to a fine not less than two pounds or more than ten pounds, and his license shall be forfeited and he shall be prohibited from carrying a gun for a period of not less than twelve months or more than five years from the date of conviction.

Provided always that in every case on conviction of an offence under this Law the gun shall be confiscated.

Property to vest in body corporate. BE it enacted :-

1. This Law may be cited as the Charities Law, 1925.

[March 24, 1925.

2. It shall be lawful for the trustees for the time being of any charity for educational, literary, scientific or public charitable purposes to apply in manner hereinafter mentioned, to the High Commissioner for a certificate of registration of the trustees of any such charity as a corporate body; and if the High Commissioner in Council shall consider such incorporation expedient, he may grant such certificate accordingly, subject to such conditions or directions as he shall think fit to insert in the certificate relating to the qualifications and number of the trustees, their tenure or avoidance of office and the mode of appointing new trustees; and the trustees of such charity shall thereupon become a body corporate by the name described in the certificate, and shall have perpetual succession and a common seal, of which the device shall be approved by the High Commissioner, and power to sue and be sued in their corporate name, and to hold, acquire transfer, assign and demise any movable or immovable property for the purposes of such charity.

3. The certificate of incorporation shall vest in such body corporate all the movable and immovable property belonging to or held by any person or persons in trust for such charity, and thereupon any person or persons in whose name or names any stocks, funds, securities or
