TO REGULATE SANITATION AND OTHER MATTERS IN HOTELS AND PUBLIC BUILDINGS.

BE it enacted :-

1. This Law may be cited as the Hotels and Public Buildings Regulation Law, 1928.

2. In this Law:-

"Hotel" means any hotel, boarding-house, restaurant or other building used for the accommodation of the public situated elsewhere than in a Municipal area.

"Public Building" includes any building used as a theatre, cinema or other building used for the entertainment of the public situated elsewhere than in a Municipal area.

3. The Governor in Council may by Order make Regulations to be published in the Cyprus Gazette for all or any of the following matters :--

(1) Sanitation in any hotel or public building;

Interpretation.

Power to Governor in Council to make Regulations.

(2) \The cleanliness and disinfection of the premises, and of all instruments, appliances, furniture, utensils, fixtures and accessories used in connection with the business carried on in any hotel or public building;

(3) The protection from contamination by dust, flies and otherwise of all articles intended, exposed, or offered for sale for human consumption in such hotels or public buildings;

(4) The precautions to be taken against the spread of infection or communication of disease from, to, or amongst persons on such premises, whether occupiers, employers, employees, guests, or customers;

(5) The painting, varnishing, distempering or limewashing of the inner and outer walls, and of all fixtures, counters, shelves, doors, windows and partitions of such hotels or public buildings:

(6) The duties of owners and occupiers with regard to the removal and disposal of all refuse and waste matters from such hotels or public buildings;

(7) The inspection of hotels or public buildings;

(8) Accommodation and safety in any hotel or public building;

(9) The design, including plans, elevations, sections and specifications, of any hotel or public building hereafter to be constructed or erected;

(10) The appointment of Committees to supervise or perform any operation, matter or thing prescribed by any regulations made hereunder.

4. The Governor in Council may by Order to be published Power to in the Cyprus Gazette direct that this Law shall be applied Governor in Council to to hotels or public buildings situated within any Municipal apply this area, and from and after the date of the publication of Law to such Order, or such date as may be named in that behalf public in the Order, this Law shall be in full force and effect in respect of hotels or public buildings situated within the Municipal Municipal area to which such Order refers. Provided that and notwithstanding anything in any other Law contained :-

(1) The Municipal Council exercising authority over the Municipal area to which such Order refers may make Bye-laws for all or any of the matters specified in section 3 of this Law;

hotels or buildings in any area.

(2) Any Bye-laws made by any Municipal Council under section 4 (1) of this Law shall be subject to the approval of the Governor in Council, and shall not come into force until they have been approved by the Governor in Council and published in the *Cyprus Gazette*, and shall have the force of law from the date of such publication;

(3) If at any time it shall appear to the Governor that for all or any of the matters specified in section 3 of this Law there are no Bye-laws for the time being in force for hotels or public buildings within a Municipal area to which this Law has been made applicable by Order as aforesaid, the Governor may by notice require the Municipal Council concerned to make and submit to him such Bye-laws; and if the Municipal Council makes default in making Bye-laws accordingly and obtaining confirmation thereof within the time limited by the notice, the Governor in Council may make Bye-laws, and such Bye-laws shall on being published in the Cyprus Gazette have the same effect as if they have been made by the Municipal Council and confirmed by the Governor in Council.

Penalties for breaches of Regulations or Bye-laws. 5. Regulations or Bye-laws made under this Law may provide for the imposition on offenders against the same of penalties not exceeding five pounds for each offence, and in case of a continuing offence a further penalty not exceeding two pounds for each day during which the offence continues.

Provided that all penalties recovered under any Byelaws made under this Law for offences committed within a Municipal area shall be paid to the fund of the Municipality concerned.
