- (3) The person in charge of any omnibus who shall charge or attempt to charge any fare other than the fare fixed under the provisions of this Law shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding five pounds.
- 10. This Law shall expire on the thirty-first day of Duration December one thousand nine hundred and thirty-one.

BE it enacted:-

1. This Law may be cited as the Customs and Excise Shorttitle: Regulation (Amendment, No. 3) Law, 1930, and shall be read as one with the Customs and Excise Regulation Law, 1879, (hereinafter referred to as the principal law), the Customs and Excise Regulation (Amendment) Law, 1924, the Customs and Excise Regulation (Amendment) Law, 1927, the Customs and Excise Regulation (Amendment, No. 2) Law, 1927, the Customs and Excise Regulation (Amendment) Law, 1928, the Customs and Excise Regulation (Amendment, No. 2) Law, 1928, the Customs and Excise Regulation (Amendment, No. 2) Law, 1930, and the Customs and Excise Regulation (Amendment, No. 2) Law, 1930, and the principal law and the said Laws and this Law may together be cited as the Customs and Excise Regulation Laws, 1879 to (No. 3) 1930.

Addition of new section to principal law.

2. The following section shall be inserted in the principal law as section 62:—

Exportation of certain goods prohibited unless they bear a mark of origin. "62.—(1) The exportation from the Colony of Cyprus to the United Kingdom of Great Britain and Northern Ireland of any of the goods specified in the first column of the fifth schedule hereto is prohibited unless such goods bear a mark of origin to be affixed, stamped or attached thereto or thereon in the manner described in the second column of the said schedule.

Mark of origin defined and manner of representing it. (2) For the purposes of this Law the expression "mark of origin" means a mark in such form as the Comptroller of Customs and Excise may from time to time determine, and may be represented by adhesive label or stencil or impression by rubber stamp to be affixed, stamped or attached to or on any goods which may be exported from the Colony of Cyprus under the provisions of this Law."

Addition of new section to principal law.

3. The following section shall be inserted in the principal law as section 63:—

Power to Governor in Council to control exportation of animals.

- "63. The Governor in Council may, from time to time, by Order prohibit,
 - (a) absolutely, or
- (b) except upon conditions provided in such Order, the exportation of all or any animals from the Colony of Cyprus, and may vary or revoke such Order.

Addition of new section to principal law. 4. The following shall be inserted in the principal law as section 64:—

Penalties.

"64. Any person who exports or attempts to export any goods in contravention of section 62 of this Law or any animals in contravention of any Order issued under section 63 of this Law shall be liable to a penalty not exceeding twenty pounds, and all such goods or animals exported or attempted to be exported may be liable to forfeiture,"

5. The following schedule shall be inserted in the Addition of principal law as fifth schedule :-

"FIFTH SCHEDULE (SECTION 62).

Goods.

Manner of affixing, stamping or attaching the Mark of Origin.

Honey in jars. Jam in tins or bottles. Marmalade in tins or bottles. Marmalade pulp in tins or bottles.

Preserved fruit in tins or bottles.

Dried fruit in boxes containing one oke or less.

Locoum in boxes containing one oke or less.

Any other fruits, nuts and sweets in small retail receptacles.

Brandy in bottles. Wine in bottles.

Cigarettes in tins or boxes.

Oranges and lemons.

Silk goods, cotton goods and lace.

By adhesive label to be affixed on the jar, tin,

bottle, box or other

receptacle containing the goods.

Wrappers in paper to bear the Mark of Origin by print thereon and the cases, boxes or other containers to bear the Mark of Origin stamped

By adhesive label affixed or attached to the goods.
