BE it enacted :—

Short title.

1. This Law may be cited as the Corporate Bodies (Immovable Property Registration) Law, 1931, and shall be read as one with the Corporate Bodies (Immovable Property Registration) Law, 1908, (hereinafter referred to as the principal Law), and the principal Law and this Law may together be cited as the Corporate Bodies (Immovable Property Registration) Laws, 1908 and 1931.

Amendment
of principal
Law.

2. The principal Law is hereby amended as follows :—

(a) The following paragraph shall be substituted for paragraph (c) of the definition of "Corporate Body" :—

"(c) Any Collectif, Commandite or Anonyme partnership or company formed under the Ottoman Commercial Code and qualified to pursue its business within Cyprus or any partnership registered under the provisions of the Partnership Law, 1928, or any company registered under the provisions of the Companies (Limited Liability) Law, 1922, or any Co-operative Credit Society registered under the provisions of the Co-operative Credit Societies Laws, 1914 to 1929, or any Co-operative Society registered under the provisions of the Co-operative Societies Law, 1923 ;"

(b) The following words shall be inserted in section 4, sub-section (3) (a), between the words "Company" and " , a " (line two),

"formed under the Ottoman Commercial Code and qualified to pursue its business within Cyprus".

(c) The following paragraphs shall be added to section 4, sub-section (3), as (c), (d), (e) and (f) :—

"(c) In the case of a partnership registered under the provisions of the Partnership Law, 1928, the certificate of the Registrar of Partnerships, or a certified copy thereof, of the registration of such partnership ;

(d) In the case of a company registered under the provisions of the Companies (Limited Liability) Law, 1922, the certificate of the Registrar of Companies, or a certified copy thereof, of the incorporation of such company ;

(e) In the case of a Co-operative Credit Society the certificate of the Registrar of Co-operative Credit Societies, or a certified copy thereof, of the registration of such society ;

(f) In the case of a Co-operative Society the certificate of the Registrar of Co-operative Societies, or a certified copy thereof, of the registration of such society.”

3. Any immovable property registered in the books of the Land Registry Office prior to the coming into operation of this Law in the name of any partnership registered under the provisions of the Partnership Law, 1928, or of any company registered under the provisions of the Companies (Limited Liability) Law, 1922, or of any Co-operative Credit Society registered under the provisions of the Co-operative Credit Societies Laws, 1914 to 1929, or of any Co-operative Society registered under the provisions of the Co-operative Societies Law, 1923, shall be deemed to have been so registered under and in accordance with and subject to the provisions of the principal Law.
