(d) The maximum period during which such goods, wares or merchandise shall be exported :

(e) The forms of declarations and other documents to be executed or used by the exporter and any other person before drawback is granted, paid or allowed on such goods, wares or merchandise.

(2) All regulations made under this section shall be published in the Cyprus Gazette, and shall thereupon have the like force and effect as if enacted herein, either immediately or on and from such other date as may therein or in that regard be provided.

(3) All regulations made under this section may from time to time be altered, amended or revoked in like manner by the Governor in Council."

3. This Law shall come into operation upon a date to be fixed by notice by the Governor in the Cyprus Gazette and thereupon the Customs, Excise and Revenue Law, 1928, section 4, shall be repealed.

1. This Law may be cited as the Communication with Short title. Vessels Law, 1932.

2. Notwithstanding anything contained in any other Law, Power to the Governor in Council may, with the sanction of the make regulations. Secretary of State, from time to time, make regulations for the better control in Cyprus of,

(a) persons landing, or desirous of landing from any vessel, and

(b) communication between vessels and the shore or any other vessel.

Every such regulation when made shall be published in the Cyprus Gazette :

Provided that until varied or revoked by any such regulations the regulations contained in the schedule to this Law shall be in force.

3.—(1) Any person who,

(a) acts in contravention of, or

(b) aids or abets any person in acting in contravention Offences. of. or
