1. This Law may be cited as the Municipal Corporations short title. Law, 1932, and shall be read as one with the Municipal Corporations Law, 1930, (hereinafter referred to as the principal Law), and the principal Law and this Law may together be cited as the Municipal Corporations Laws, 1930 and 1932.

2. BE it enacted :-

1. This Law may be cited as the Special Constables short title. Law. 1932.

2. In this Law—

"Commandant" means the Chief Commandant of the Cyprus Military Police.

"Local Commandant" means a Local Commandant of the Cyprus Military Police.

3. It shall be lawful for the Commandant, subject to Enlistment. the approval of the Governor, to accept the services of any persons willing to be enrolled as Special Constables provided always that the first term of enrolment shall be for not less than two years from the date of attestation.

4. Every Special Constable shall upon enrolment take Form of and subscribe the following oath according to the form Special prescribed by his religion to be administered by the Com- Constables. mandant or a Local Commandant :-

I, A.B., do sincerely promise and swear that I will well and truly serve our Sovereign lord the King in the office of Special Constable without favour or affection, malice or ill will; and that I will to the best of my power cause the peace to be kept and preserved and prevent all offences against persons and property and that while I continue to hold the said office I will to the best of my skill and knowledge discharge all the duties thereof faithfully according to law
