A LAW TO AMEND THE MOTOR CAR LAW, 1921.

BE it enacted:-

Short title.

1. This Law may be cited as the Motor Car (Amendment) Law, 1932, and shall be read as one with the Motor Car Law, 1921, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Motor Car Laws, 1921 and 1932.

Amendment of section 3 of the Principal Law. 2. Section 3 of the Principal Law is hereby amended by the addition thereto of the following sub-sections:—

"(g) The inspection from time to time of motor cars plying for hire and the levying of fees in respect thereof not exceeding the amount specified in the first part of the Third Schedule hereto.

(h) The testing of and the issue to persons driving motor cars of certificates of competence and the levying of fees in respect thereof not exceeding the amount specified in the second part of the Third Schedule hereto:

Provided that a person who prior to the commencement of this Law has held a licence to drive a motor car shall be deemed to hold a certificate of competence under the provisions of this Law."

3. The following shall be inserted as the Third Schedule Addition of to the Principal Law:

A LAW TO REGULATE AND IMPROVE THE SUPPLY AND A.D. 1932. DISTRIBUTION OF WATER TO CERTAIN VILLAGES FOR 37 of 1932. Drinking and other Domestic Purposes.

HEREAS the inhabitants of the villages in the Schedule to this Law are entitled to the use of water from the spring known as "Kefalovriso" near the village of Kythræa in the District of Nicosia for drinking and other domestic purposes;

AND WHEREAS the quantity of such water for the use of the said inhabitants of each village as aforesaid has been estimated to be not more than the quantity in the Schedule to this Law appearing against the name of each such village for each day;

AND WHEREAS it is necessary in the interests of public health that provision be made for improving the means of conveyance of water from the spring aforesaid to the villages aforesaid;
