BE it enacted :-

1. This Law may be cited as the Firearms (Amendment) Short title. Law, 1934, and shall be read as one with the Firearms Law, 1933, (hereinafter called "the Principal Law"), 31 of 1933. and the Principal Law and this Law may together be cited as the Firearms Laws, 1933 to 1934.

2. The definition of "Local Commandant" in section 2 Amendment of the Principal Law is hereby amended by the insertion of section 2 of Law 31 immediately after the word "Police" of the words "or of 1933. officer for the time being in charge of the Police ".

3. Section 3 of the Principal Law is hereby amended Amendment as follows :-

- (a) by the insertion in sub-section (2) immediately after the word "importation" of the words "or possession ";
