BE it enacted :-

1. This Law may be cited as the Tobacco (Amendment) short title. Law, 1934, and shall be read as one with the Tobacco Laws, 1932 and 1933, (hereinafter called "the Principal 40 of 1932. 39 of 1933. Law "), and the Principal Law and this Law may together be cited as the Tobacco Laws, 1932 to 1934.

4. Section 27 of the Principal Law is hereby repealed Repeal of and the following section substituted therefor :--

" Licensee to enter into bond.

27. No factory licence shall be issued unless of 1932 and substitution the licensee enters into a bond with such surety of new section. as the Comptroller may require, whereby such licensee undertakes to manufacture for export or for local consumption during each and every year commencing from the date of issue of the licence a quantity of not less than four thousand okes of tobacco or in default to pay to the Comptroller for any difference between four thousand okes and the amount manufactured the consumption duty prescribed by section 38 of this Law."

5. Sub-section (3) of section 34 of the Principal Law is Amendment hereby amended by the insertion immediately after the of section 34 words "Any manufacturer who" in line one, of the word 40 of 1932. "knowingly".

6. Sub-section (1) (a) of section 40 of the Principal Law Amendment is hereby amended by the deletion therefrom of the 40 (1) (a) of words "two drams or".

Amendment of section 59 of Law 40 of 1932.

7. Section 59 of the Principal Law is hereby amended by the addition of the following sub-section, the first part thereof being numbered accordingly :-

"(2) In any prosecution under section 13 (2), 21 (3) or 34 (3) where it is proved that the information given was false, the accused shall, unless he shall satisfy the Court to the contrary, be deemed to have given such information knowing the same to be false."

8. Any bond entered into by a licensee before the enactment of this Law shall be valid and effective as if this Law had not been enacted.

1. This Law may be cited as the Charities (Amendment) Law, 1934, and shall be read as one with the Charities Laws, 1925 and 1932, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Charities Laws, 1925 to 1934.

2. Section 12 of the Principal Law is hereby amended as of section 12 follows :-

(a) By the deletion of sub-section (2) and by the substitution therefor of the following sub-section :----

"(2) Such enrolment shall be effected by the depositing with the Registrar of the Supreme Court of the deed, will or other instrument."

(b) By the deletion of sub-section (3) and by the substitution therefor of the following sub-section :----

"(3) A copy certified by the Registrar to be a true copy of a deed, will or other instrument enrolled in his office shall be received as evidence of the contents and enrolment of such deed, will or other instrument."

(c) By the deletion of sub-section (4).
